MADAM PRESIDENT:

I move that Engrossed House Bill 1365 be amended to read as follows:

1	Page 4, delete lines 31 through 38.
2	Page 7, between lines 2 and 3, begin a new paragraph and insert:

6	reports from the voter registration information from the computerized
7	list for the purposes specified under IC 3-7-26.3-29.

18	(2) the part or report is a purely statistical compilation that:
19	(A) includes the information described in section 8 of this

21	(B) does not include any information:
22	(i) concerning an individual voter; or
23	(ii) that would permit the identification of an individual
24	voter as a result of providing the compilation.
25	(d) The parts and reports provided under this section may not
26	include the complete Social Security number of any individual.
