MR. SPEAKER:

I move that House Bill 1502 be amended to read as follows:

- 1 Page 5, after line 2, begin a new paragraph and insert:
2 "SECTION 2. IC 5-10-8-27.7 IS ADDED TO THE INDIANA
3 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
4 [EFFECTIVE JULY 1, 2025]: **Sec. 27.7. (a) This section applies to a**
5 **state employee health plan that is established, entered into,**
6 **amended, or renewed after June 30, 2025.**
7 **(b) As used in this section, "covered individual" means an**
8 **individual entitled to coverage under a state employee health plan.**
9 **(c) As used in this section, "state employee health plan" means**
10 **the following:**
11 **(1) A self-insurance program established under section 7(b) of**
12 **this chapter.**
13 **(2) A contract for prepaid health care services entered into**
14 **under section 7(c) of this chapter.**
15 **The term does not include a dental plan.**
16 **(d) A state employee health plan shall limit the total amount a**
17 **covered individual is required to pay for auto-injectable**
18 **epinephrine that is prescribed for the covered individual to an**
19 **amount not to exceed twenty-five dollars (\$25) per month,**
20 **regardless of the number of prescriptions and types of**
21 **auto-injectable epinephrine prescribed and filled for the covered**
22 **individual that month.**

(e) A state employee health plan may reduce the total amount a covered individual is required to pay for auto-injectable epinephrine that is prescribed for the covered individual per month to an amount less than the amount of the limit specified in subsection (d).

SECTION 3. IC 5-10-8-28.7 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2025]: Sec. 28.7. (a) This section applies to a state employee health plan that is established, entered into, amended, or renewed after June 30, 2025.

(b) As used in this section, "covered individual" means an individual entitled to coverage under a state employee health plan.

(c) As used in this section, "state employee health plan" means the following:

(1) A self-insurance program established under section 7(b) of this chapter.

(2) A contract for prepaid health care services entered into under section 7(c) of this chapter.

The term does not include a dental plan.

(d) A state employee health plan shall limit the total amount a covered individual is required to pay for albuterol asthma inhalers that are prescribed for the covered individual to an amount not to exceed fifty-five dollars (\$55) per month, regardless of the number of prescriptions and types of albuterol asthma inhalers prescribed and filled for the covered individual that month.

(e) A state employee health plan may reduce the total amount a covered individual is required to pay for albuterol asthma inhalers that are prescribed for the covered individual per month to an amount less than the amount of the limit specified in subsection (d).

SECTION 4. IC 5-10-8-29.7 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2025]: Sec. 29.7. (a) This section applies to a state employee health plan that is established, entered into, amended, or renewed after June 30, 2025.

(b) As used in this section, "covered individual" means an individual entitled to coverage under a state employee health plan.

(c) As used in this section, "prescription insulin drug" means a prescription drug that:

(1) contains insulin;

(2) is used to treat diabetes; and

(3) has been prescribed as medically necessary.

(d) As used in this section, "state employee health plan" means the following:

(1) A self-insurance program established under section 7(b) of this chapter.

(2) A contract for prepaid health care services entered into under section 7(c) of this chapter.

1 **The term does not include a dental plan.**

2 **(e) A state employee health plan shall limit the total amount a**
3 **covered individual is required to pay for insulin drugs that are**
4 **prescribed for the covered individual to an amount not to exceed**
5 **thirty-five dollars (\$35) per month, regardless of the number of**
6 **prescriptions and types of prescription insulin drugs prescribed**
7 **and filled for the covered individual that month.**

8 **(f) A state employee health plan may reduce the total amount a**
9 **covered individual is required to pay for insulin drugs that are**
10 **prescribed for the covered individual per month to an amount less**
11 **than the amount of the limit specified in subsection (e)."**

12 Renumber all SECTIONS consecutively.
