



SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 105 be amended to read as follows:

- 1 Page 1, between lines 4 and 5, begin a new paragraph and insert:
- 2 "Sec. 1. As used in this chapter, "advisory board" refers to the
- 3 **Indiana Drainage Handbook advisory board."**
- 4 Page 1, line 5, delete "1." and insert "2."
- 5 Page 1, line 7, delete "2." and insert "3."
- 6 Page 1, line 13, delete "3." and insert "4."
- 7 Page 2, line 4, delete "4" and insert "5".
- 8 Page 2, delete lines 5 through 42, begin a new paragraph and insert:
- 9 "**Sec. 5. (a) The secretary of agriculture and rural development**
- 10 **shall appoint an Indiana Drainage Handbook advisory board to:**
- 11 **(1) advise the contractor and the department on the**
- 12 **preparation of the updated version of the Indiana Drainage**
- 13 **Handbook; and**
- 14 **(2) review and comment on:**
- 15 **(A) the structure of; and**
- 16 **(B) the text of drafts of;**
- 17 **the updated version of the Indiana Drainage Handbook.**
- 18 **(b) The advisory board must include the following:**
- 19 **(1) A representative of the department.**
- 20 **(2) A licensed county surveyor.**
- 21 **(3) A county commissioner.**
- 22 **(4) A representative of a soil and water conservation district.**
- 23 **(5) A licensed engineer.**
- 24 **(6) A representative of the department of natural resources.**
- 25 **(7) A representative of the department of environmental**
- 26 **management.**
- 27 **(8) A farmer.**

- 1 **(9) A representative of the construction industry.**
- 2 **(10) A representative of the United States Fish and Wildlife**
- 3 **Service.**
- 4 **(11) A representative of the United States Army Corps of**
- 5 **Engineers.**
- 6 **(12) A representative of the United States Department of**
- 7 **Agriculture's Natural Resources Conservation Service.**
- 8 **(13) An individual focused on environmental stewardship and**
- 9 **sustainability.**
- 10 **(c) The secretary of agriculture and rural development shall**
- 11 **appoint one (1) member of the advisory board as chairperson.**
- 12 **(d) A member of the advisory board serves until:**
- 13 **(1) the updated version of the Indiana Drainage Handbook is**
- 14 **published on the website of the department of natural**
- 15 **resources or the department; and**
- 16 **(2) the secretary of agriculture and rural development**
- 17 **declares that the work of the advisory board is concluded.**
- 18 **(e) A vacancy on the advisory board shall be filled by**
- 19 **appointment by the secretary of agriculture and rural**
- 20 **development.**
- 21 **Sec. 6. (a) The advisory board may not take official action or**
- 22 **make official recommendations on:**
- 23 **(1) general drainage policies;**
- 24 **(2) the text of drafts of the updated version of the Indiana**
- 25 **Drainage Handbook; or**
- 26 **(3) the structure of the updated version of the Indiana**
- 27 **Drainage Handbook.**
- 28 **(b) Advice and comments provided by the advisory board are**
- 29 **not binding on the department or the contractor selected under**
- 30 **section 4 of this chapter.**
- 31 **Sec. 7. (a) The advisory board shall meet at the call of the**
- 32 **chairperson. After the contractor is selected under section 4 of this**
- 33 **chapter, the advisory board:**
- 34 **(1) shall meet at least two (2) times to review the work of the**
- 35 **contractor; and**
- 36 **(2) may meet at other times at the call of the chairperson as**
- 37 **the contractor's work on the updated Indiana Drainage**
- 38 **Handbook progresses.**
- 39 **(b) The expenses of the advisory board shall be paid from funds**
- 40 **appropriated to the department.**
- 41 **(c) Each member of the advisory board who is not a state**
- 42 **employee is entitled to the minimum salary per diem provided by**
- 43 **IC 4-10-11-2.1(b). The member is also entitled to reimbursement**
- 44 **for traveling expenses as provided under IC 4-13-1-4 and other**
- 45 **expenses actually incurred in connection with the member's duties**
- 46 **as provided in the state policies and procedures established by the**
- 47 **Indiana department of administration and approved by the budget**

2 **Sec. 8. (a) The department shall staff the advisory board.**
3 **(b) The department may record and keep records of comments**
4 **provided by the advisory board to the department or the**
5 **contractor selected under section 4 of this chapter."**
