



# SENATE MOTION

**MADAM PRESIDENT:**

**I move** that Senate Bill 202 be amended to read as follows:

- 1           Page 17, delete lines 7 through 29, begin a new paragraph and  
2 insert:  
3           **"Sec. 4. Not later than September 1, 2024, each institution shall**  
4 **submit the following to the commission for higher education and**  
5 **the state budget committee:**  
6           **(1) Data describing the institution's budget allocations for**  
7 **diversity, equity, and inclusion initiatives.**  
8           **(2) Information regarding the definitions, guidelines, and**  
9 **parameters the institution used in determining which**  
10 **initiatives were considered by the institution to be diversity,**  
11 **equity, and inclusion initiatives.**  
12 **This section expires July 1, 2025.**  
13           **Sec. 5. Not later than November 1, 2024, the commission for**  
14 **higher education shall do the following:**  
15           **(1) Review the information submitted by the institutions**  
16 **under section 4 of this chapter.**  
17           **(2) Recommend to the budget committee consistent**  
18 **definitions, guidelines, and parameters that would allow the**  
19 **information submitted under section 4 of this chapter to be**  
20 **compared across institutions and academic years.**  
21 **This section expires July 1, 2025.**  
22           **Sec. 6. At the time an institution submits its legislative budget**  
23 **request, the institution shall, in a manner prescribed by the state**  
24 **budget committee, submit to the state budget committee data**  
25 **describing the institution's budget allocations for diversity, equity,**  
26 **and inclusion initiatives."**  
27           Page 18, delete lines 32 through 42, begin a new paragraph and  
28 insert:

1           "SECTION 38. IC 21-49-4 IS ADDED TO THE INDIANA CODE  
2 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2024]:

4           **Chapter 4. State Educational Institution Information Reporting**

5           **Sec. 1. Not later than September 1, 2024, each state educational**  
6 **institution shall submit to the commission for higher education and**  
7 **the state budget committee the following information:**

8           (1) For each academic year, beginning with the 2017-2018  
9 academic year, the total number of state educational  
10 institution:

11           (A) full-time and tenured professors;

12           (B) adjunct instructors;

13           (C) other contingent faculty; and

14           (D) nonacademic support or administrative employees.

15           (2) For each academic year, the total number of employees at  
16 the state educational institution whose primary or secondary  
17 job duties or job titles include diversity, equity, and inclusion.

18           (3) For each academic year, the total number of state  
19 educational institution adjudications or proceedings  
20 regarding violations of policies regarding diversity, equity,  
21 and inclusion or harassment.

22           (4) A list and description of what the state educational  
23 institution does to ensure free speech rights of students.

24           (5) A list and description of what the state educational  
25 institution does to ensure intellectual freedom for professors.

26           (6) A list and description of what the state educational  
27 institution does to ensure intellectual and ideological diversity  
28 of professors.

29           (7) Information regarding the definitions, guidelines, and  
30 parameters the institution used in determining which  
31 information under subdivisions (1) through (6) to include in  
32 the submission under this section.

33           **This section expires July 1, 2025.**

34           **Sec. 2. Not later than November 1, 2024, the commission for**  
35 **higher education shall do the following:**

36           (1) Review the information submitted by the institutions  
37 under section 1 of this chapter.

38           (2) Recommend to the budget committee consistent  
39 definitions, guidelines, and parameters that would allow the  
40 information submitted under section 1 of this chapter to be  
41 compared across state educational institutions and academic  
42 years.

43           **This section expires July 1, 2025.**

44           **Sec. 3. At the time a state educational institution submits its**  
45 **legislative budget request, the state educational institution shall, in**  
46 **a manner prescribed by the state budget committee, submit to the**  
47 **state budget committee the following information:**

- 1           **(1) For each academic year, the total number of state**
- 2           **educational institution:**
- 3           **(A) full-time and tenured professors;**
- 4           **(B) adjunct instructors;**
- 5           **(C) other contingent faculty; and**
- 6           **(D) nonacademic support or administrative employees.**
- 7           **(2) For each academic year, the total number of employees at**
- 8           **the state educational institution whose primary or secondary**
- 9           **job duties or job titles include diversity, equity, and inclusion.**
- 10          **(3) For each academic year, the total number of state**
- 11          **educational institution adjudications or proceedings**
- 12          **regarding violations of policies regarding diversity, equity,**
- 13          **and inclusion or harassment.**
- 14          **(4) A list and description of what the state educational**
- 15          **institution does to ensure free speech rights of students.**
- 16          **(5) A list and description of what the state educational**
- 17          **institution does to ensure intellectual freedom for professors.**
- 18          **(6) A list and description of what the state educational**
- 19          **institution does to ensure intellectual and ideological diversity**
- 20          **of professors."**
