MR. SPEAKER:

*Your Committee on Courts and Criminal Code, to which was referred House Bill 1004, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, delete lines 7 through 12.
- 2 Page 2, line 8, after "suspend" insert "**any portion of**".
- 3 Page 2, line 10, delete "." and insert "**for the part of the sentence**
- 4 **which must be executed under IC 35-50-2-2.1 or IC 35-50-2-2.2.**"
- 5 Page 2, delete lines 31 through 37.
- 6 Page 4, delete lines 29 through 42.
- 7 Page 5, delete lines 1 through 13, begin a new paragraph and insert:
- 8 "SECTION 7. IC 35-38-2.6-6, AS AMENDED BY P.L.26-2019,
- 9 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 10 JULY 1, 2022]: Sec. 6. (a) As used in this section, "home" means the
- 11 actual living area of the temporary or permanent residence of a person.
- 12 (b) A person confined on home detention in a community
- 13 corrections program receives one (1) day of accrued time for each day
- 14 the person is confined on home detention, plus any earned good time

1 credit.

2 (c) In addition to accrued time under subsection (b), a person who
 3 is placed ~~in~~ **on a level of supervision as part of** a community
 4 corrections program under this chapter is entitled to earn good time
 5 credit under IC 35-50-6-3 and IC 35-50-6-3.1. A person ~~confined on~~
 6 **home detention placed on a level of supervision** as part of a
 7 community corrections program may not earn educational credit under
 8 IC 35-50-6-3.3.

9 (d) The department of correction shall adopt rules under IC 4-22-2,
 10 and may adopt emergency rules under IC 4-22-2-37.1, concerning the
 11 deprivation of earned good time credit for a person who is placed ~~in~~ **on**
 12 **a level of supervision as part of** a community corrections program
 13 under this chapter.

14 (e) A person who is placed ~~in~~ **on a level of supervision as part of**
 15 a community corrections program under this chapter may be deprived
 16 of earned good time credit as provided under rules adopted by the
 17 department of correction under IC 4-22-2, including IC 4-22-2-37.1.".

18 Renumber all SECTIONS consecutively.
 (Reference is to HB 1004 as introduced.)
