8	(3) Psychiatric residencies.

17	(b) Before July 1, 2022, the state department shall submit and

2	maintain on the department's Internet web site a web page that
2	indicates the performance and progress of the metrics and goals
4	identified in the plan prepared under subsection (a).
5	(d) Before July 1, 2023, and before July 1 of each year
6	thereafter, the state department shall prepare, submit, and present
7	to the interim study committee on public health, behavioral health,
8	and human services established by IC 2-5-1.3-4 a report on the
9	grants awarded under IC 16-46-16.5-6 and the progress made in
10	meeting the metrics and goals identified in the plan submitted
11	under this section.".

13	Page 3, line 38, delete "give preference to proposals that seek to do
14	any" and insert "award grants only for prevention proposals that
15	will invest in any of the following:
16	(1) Paths to quality training.
17	(2) Loan forgiveness programs administered by the state
18	department and the office of the secretary of family and social
19	services.
20	(3) Psychiatric residencies.
21	(4) Training for professionals to address mental health issues
22	in schools.
