*Your Committee on Government and Regulatory Reform, to which was referred House Bill 1026, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

 25 **IC 4-13-1-4 and other expenses actually incurred in connection**

 28 **administration and approved by the budget agency.**

 16 individual, partnership, corporation, limited liability company, or joint
 17 venture of any kind that is owned and controlled by one (1) or more
 18 persons who are:
- 19 (1) United States citizens; and
- 20 (2) members of a minority group or a qualified minority nonprofit
 21 corporation.
- 22 (i) "NGB-22" means the National Guard Report of Separation form
 23 or its predecessor or successor form.
- 24 (j) "Qualified minority or women's nonprofit corporation" means a
 25 corporation that:
- 26 (1) is exempt from federal income taxation under Section
 27 501(c)(3) of the Internal Revenue Code;
- 28 (2) is headquartered in Indiana;
- 29 (3) has been in continuous existence for at least five (5) years;
- 30 (4) has a board of directors that has been in compliance with all
 31 other requirements of this chapter for at least five (5) years;
- 32 (5) is chartered for the benefit of the minority community or
 33 women; and
- 34 (6) provides a service that will not impede competition among
 35 minority business enterprises or women's business enterprises at
 36 the time a nonprofit applies for certification as a minority
 37 business enterprise or a women's business enterprise.
- 38 (k) "Owned and controlled" means:

- 1 (1) if the business is a qualified minority nonprofit corporation, a
2 majority of the board of directors are minority;
- 3 (2) if the business is a qualified women's nonprofit corporation,
4 a majority of the members of the board of directors are women; or
5 (3) if the business is a business other than a qualified minority or
6 women's nonprofit corporation, having:
- 7 (A) ownership of at least fifty-one percent (51%) of the
8 enterprise, including corporate stock of a corporation;
- 9 (B) control over the management and active in the day-to-day

- 11 (C) an interest in the capital, assets, and profits and losses of

- 24 (o) "Veteran" means an individual who:
- 25 (1) has previously:
- 26 (A) served on active duty in any branch of the armed forces of
27 the United States or their reserves, in the national guard, or in
28 the Indiana National Guard; and
- 29 (B) received an honorable discharge from service; or
- 30 (2) is currently serving in:
- 31 (A) any branch of the armed forces of the United States or
32 their reserves;
- 33 (B) the national guard; or
- 34 (C) the Indiana National Guard.
- 35 (p) "Veteran owned small business" refers to a small business that:
- 36 (1) is independently owned and operated;
- 37 (2) is not dominant in its field of operation; and
- 38 (3) satisfies the criteria to be a veteran owned small business

- 1 concern as specified in section 1.5 of this chapter.
- 2 (q) "Women's business enterprise" means a business that is one (1)
- 3 of the following:
- 4 (1) A sole proprietorship owned and controlled by a woman.
- 5 (2) A partnership or joint venture owned and controlled by
- 6 women in which:
- 7 (A) at least fifty-one percent (51%) of the ownership is held by
- 8 women; and
- 9 (B) the management and daily business operations are
- 10 controlled by at least one (1) of the women who owns the

- 13 (A) whose management and daily business operations are
- 14 controlled by at least one (1) of the women who owns the
