Summary of Legislation: This bill provides that the following are eligible for a mobile integration healthcare grant:

- (1) an emergency medical services (EMS) provider agency that is operated by a county;
- (2) an EMS provider organization; and
- (3) a hospital; if certain conditions are met.

Effective Date: July 1, 2025.

Explanation of State Expenditures: The Department of Homeland Security's Emergency Medical Services Commission (Commission) will need to update documentation to include additional entities, as prescribed in the bill, as eligible applicants for mobile integration healthcare grants and may receive additional applications for review. This is within the Commission's routine administrative functions and should be able to be implemented using existing staffing and resources.

Additional Information: The Commission was appropriated \$500,000 each year for the FY 2024-FY 2025 biennium. The Commission offered grants ranging from \$50,000 to \$75,000 in FY 2024 and awarded the full appropriation of \$500,000 to 8 applicants. As of August 2024, the Commission has awarded \$400,000 to 6 applicants and intends to have an additional round of applications to award the remaining \$100,000.

Explanation of State Revenues: The bill expands grant eligibility, allowing state hospitals to apply to either start or expand mobile integration healthcare programs.

Explanation of Local Expenditures:

Explanation of Local Revenues: The bill expands grant eligibility, allowing counties, county-operated EMS provider agencies, and municipal hospitals to apply to either start or expand mobile integration healthcare programs.

State Agencies Affected: EMS Commission, Department of Homeland Security; state hospitals.

Local Agencies Affected: Counties; county-operated EMS provider agencies; municipal hospitals.
