## COMMITTEE REPORT

**MR. SPEAKER:**

*Your Committee on Courts and Criminal Code, to which was referred House Bill 1127, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1           Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3           "SECTION 1. IC 12-12-10 IS ADDED TO THE INDIANA CODE
- 4 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 5 JULY 1, 2021]:
- 6           **Chapter 10. Long Term Recovery Group for Southwest Indiana**
- 7 **Program**
- 8           **Sec. 1. (a) As used in this chapter, "bureau" refers to the**
- 9 **rehabilitation services bureau established by IC 12-12-1-1.**
- 10           **(b) As used in this chapter, "fund" refers to the long term**
- 11 **recovery group for Southwest Indiana fund established by section**
- 12 **2 of this chapter.**
- 13           **(c) As used in this chapter, "program" refers to the long term**

1 recovery group for Southwest Indiana program established by  
2 subsection (d).

3 (d) The long term recovery group for Southwest Indiana  
4 program is established to do the following:

5 (1) Create a local, long term residential substance use  
6 disorder recovery facility in Southwest Indiana that is  
7 effective, accessible, accountable, and sustainable.

8 (2) Provide a systematic method to facilitate the advocacy and  
9 financial support of the recovery facility.

10 (3) Alleviate Southwest Indiana's drug and homelessness  
11 problems by helping individuals recover from addiction and  
12 help them gain control of their lives and eventually reside in  
13 permanent housing.

14 (4) Alleviate the considerable annual economic impact that  
15 substance use disorders have on Southwest Indiana.

16 (5) Provide assistance and rehabilitation to individuals who  
17 are:

18 (A) incarcerated;

19 (B) hospitalized;

20 (C) homeless or housed in homeless shelters;

21 (D) living in transitional housing;

22 (E) being treated in emergency rooms;

23 (F) at risk of committing suicide; and

24 (G) at risk of experiencing an overdose on opiates and  
25 other drugs.

26 (6) Serve as a pilot program for the development of other  
27 potential long term recovery sites across Indiana.

28 (7) Provide for a program within the recovery facility that  
29 undertakes a minimum six (6) month evidence based training,  
30 peer led treatment plan for Southwest Indiana residents while  
31 providing available resources for safe detoxification,  
32 appropriate medication assistance, and psychiatric support.

33 (8) Provide daily living skills classes and job responsibility  
34 classes, and promote an overall establishment of new life  
35 behaviors.

36 Sec. 2. (a) The long term recovery group for Southwest Indiana  
37 fund is established to carry out the purposes of this chapter.

38 (b) The fund consists of:

- 1           **(1) appropriations from the general assembly;**
- 2           **(2) appropriations to the fund from other sources;**
- 3           **(3) money received from state or federal grants or programs**
- 4           **for substance use disorder projects;**
- 5           **(4) donations and other grants intended for deposit in the**
- 6           **fund;**
- 7           **(5) gifts and bequests, and the proceeds of the sale of gifts and**
- 8           **bequests; and**
- 9           **(6) interest deposited into the fund under subsection (d).**
- 10          **(c) The bureau shall administer the fund. The following may be**
- 11          **paid from money in the fund:**
  - 12               **(1) Expenses of administering the fund.**
  - 13               **(2) Administrative expenses incurred to carry out the**
  - 14               **purposes of this chapter.**
  - 15               **(d) The treasurer of state shall invest the money in the fund not**
  - 16               **currently needed to meet the obligations of the fund in the same**
  - 17               **manner as other public funds may be invested. Interest that**
  - 18               **accrues from these investments must be deposited in the fund.**
  - 19               **(e) The money in the fund at the end of a state fiscal year does**
  - 20               **not revert to the state general fund.**
  - 21               **(f) The bureau shall submit to the general assembly an annual**
  - 22               **report regarding the fund. The report must include information**
  - 23               **regarding all services provided through the fund and a description**
  - 24               **of changes in the information as compared to the year preceding**
  - 25               **the year for which the report is issued.**
  - 26               **(g) The bureau shall submit the report under subsection (f):**
    - 27                       **(1) not later than June 1 of each year; and**
    - 28                       **(2) in an electronic format under IC 5-14-6."**
- 29          Renumber all SECTIONS consecutively.  
              (Reference is to HB 1127 as introduced.)
