MR. SPEAKER:

Your Committee on <u>Agriculture and Rural Development</u>, to which was referred <u>House Bill 1183</u>, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:

1	Page 1, line 6, delete "years." and insert "years, unless the
2	agricultural land is recognized by the United States Department of
3	Agriculture's Farm Service Agency as farmland.".
4	Page 2, delete lines 33 through 42, begin a new paragraph and
5	insert:
6	"SECTION 4. IC 32-22-3-1.7 IS ADDED TO THE INDIANA
7	CODE AS A NEW SECTION TO READ AS FOLLOWS
8	[EFFECTIVE JULY 1, 2024]: Sec. 1.7. As used in this chapter,
9	"controlling person" includes the following:
10	(1) A beneficial owner (as defined in IC 23-1-20-3.5) of five
11	percent (5%) or more of the shares of a business entity.
12	(2) An officer, director, or other individual who possesses
13	inside information about a business entity because of the
14	person's relationship with the business entity.
15	(3) A person, individually or as a member of a group, who has

1	the ability to directly or indirectly affect a business entity's
2	management or policies.
3	SECTION 5. IC 32-22-3-3.5 IS ADDED TO THE INDIANA CODE
4	AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
5	1, 2024]: Sec. 3.5. As used in this chapter, "prohibited person"
6	includes the following:
7	(1) An individual who is a citizen of a foreign adversary (as
8	defined in 15 CFR 7.4).
9	(2) A foreign business entity organized under the laws of a
10	foreign adversary (as defined in 15 CFR 7.4).
11	(3) A corporation, professional corporation, nonprofit
12	corporation, limited liability company, partnership, or limited
13	partnership with a controlling person who is either of the
14	following:
15	(A) An individual who is a citizen of a foreign adversary
16	(as defined in 15 CFR 7.4).
17	(B) A company or other entity, including a governmental
18	entity, that is owned or controlled by citizens of, or is
19	directly controlled by the government of, a foreign
20	adversary (as defined in 15 CFR 7.4).".
21	Page 3, delete lines 1 through 8.
22	Page 3, line 13, delete "years." and insert "years, unless the
23	agricultural land is recognized by the United States Department of
24	Agriculture's Farm Service Agency as farmland.".
25	Page 3, delete lines 26 through 35, begin a new paragraph and
26	insert:
27	"SECTION 6. IC 32-22-3-6.5 IS ADDED TO THE INDIANA
28	CODE AS A NEW SECTION TO READ AS FOLLOWS
29	[EFFECTIVE JULY 1, 2024]: Sec. 6.5. (a) Upon receipt of
30	information that leads the attorney general to believe an
31	acquisition or lease of agricultural land violates section 4.5 of this
32	chapter, the attorney general shall investigate the alleged violation
33	and may issue subpoenas requiring the:
34	(1) appearance of witnesses;
35	(2) production of relevant records; and
36	(3) giving of relevant testimony.
37	(b) If the attorney general finds that agricultural land or an
38	interest in agricultural land was acquired in violation of section 4.5

of this chapter, the attorney general shall commence an action in
the circuit court where the agricultural land is located. Upon
commencing an action under this subsection, the attorney general
shall record a notice of the pendency of the action with the county
recorder.

6 (c) If the circuit court finds that agricultural land is held in 7 violation of this chapter, the circuit court must order that the 8 agricultural land be sold through judicial foreclosure. The 9 proceeds of the sale of agricultural land through judicial 10 foreclosure will be disbursed in the following order of priority:

11 (1) First, to any lien holders, in order of priority.

12 (2) Second, to the state, for the attorney general's costs and

- expenses of the action, including reasonable attorney's feesand expert fees.".
- 15 Renumber all SECTIONS consecutively.
