## **COMMITTEE REPORT**

## **MADAM PRESIDENT:**

The Senate Committee on Corrections and Criminal Law, to which was referred Senate Bill No. 255, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

1	Page 1, between the enacting clause and line 1, begin a new
2	paragraph and insert:
3	"SECTION 1. IC 24-4-18-2, AS AMENDED BY P.L.112-2013,
4	SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
5	JULY 1, 2021]: Sec. 2. (a) As used in this section, "criminal history
6	provider" means a person or an organization that:
7	(1) compiles a criminal history report and either uses the report or
8	provides the report to a person or an organization other than a
9	criminal justice agency, a law enforcement agency, or another
10	criminal history provider; or
11	(2) regularly publishes criminal history information on the
12	Internet or regularly makes criminal history information
13	available through the Internet.
14	For purposes of subdivision (2), a person publishes or makes
15	available criminal history information "regularly" if the person
16	publishes or makes available the criminal history information of at
17	least twelve (12) individuals in a calendar year.
18	(b) The term does not include the following:
19	(1) A criminal justice agency.
20	(2) A law enforcement agency.

1	(3) Any:
2	(A) person connected with or employed by:
3	(i) a newspaper or other periodical issued at regular intervals
4	and having a general circulation; or
5	(ii) a recognized press association or wire service;
6	as a bona fide owner, editorial or reportorial employee, who
7	receives income from legitimate gathering, writing, editing,
8	and interpretation of news;
9	(B) person connected with a licensed radio or television station
10	as an owner or official, or as an editorial or reportorial
11	employee who receives income from legitimate gathering,
12	writing, editing, interpreting, announcing, or broadcasting of
13	news; or
14	(C) other person who gathers, records, compiles, or
15	disseminates:
16	(i) criminal history information; or
17	(ii) criminal history reports;
18	solely for journalistic, academic, governmental, or legal
19	research purposes.
20	(4) The clerk of a circuit, superior, city, or town court.
21	SECTION 2. IC 24-4-18-3, AS AMENDED BY P.L.112-2013,
22	SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
23	JULY 1, 2021]: Sec. 3. (a) As used in this section, "criminal history
24	report" means criminal history information that has been:
25	(1) compiled primarily for the purposes of evaluating a particular
26	person's eligibility for:
27	(1) (A) employment in Indiana;
28	(2) (B) housing in Indiana;
29	(3) (C) a license, permit, or occupational certification issued
30	under state law; or
31	(4) (D) insurance, credit, or another financial service, if the
32	insurance, credit, or financial service is to be provided to a
33	person residing in Indiana; or
34	(2) published or made available on the Internet by a criminal
35	history provider.
36	(b) The term does not include information compiled primarily for
37	the purpose of journalistic, academic, governmental, or legal research.
38	(c) The term includes information described in subsection (a) and
39	not excluded under subsection (b), regardless of the geographical
40	location of the person who compiled the information.".

- 11 expunged conviction is subject to the penalties described in
- 12 IC 24-4-18-8.".
- 13Renumber all SECTIONS consecutively.(Reference is to SB 255 as introduced.)
