ENGROSSED HOUSE BILL No. 1007

DIGEST OF HB 1007 (Updated January 16, 2020 11:07 am - DI 133)

Citations Affected: IC 4-38; IC 5-1.2; noncode.

Synopsis: Fiscal matters. Adds several standard provisions to the sports wagering fund. Repeals a provision requiring review by the budget committee of certain agreements or extensions of agreements entered into by the Indiana finance authority or the state. Appropriates money from the state general fund for various projects of Indiana's state educational institutions.

Effective: Upon passage; July 1, 2020.

ENGROSSED HOUSE BILL No. 1007

A BILL FOR AN ACT to amend the Indiana Code concerning state offices and administration and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 4-38-8-2, AS ADDED BY P.L.293-2019,
2 SECTION 43, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: Sec. 2. (a) The sports wagering fund is established.
4 (b) The commission shall administer the fund.
5 (c) The fund consists of the following:
6 (1) Initial fees deposited in the fund under IC 4-38-4-5.
7 (2) Fees deposited in the fund under IC 4-38-6.
8 (3) Fees deposited in the fund under IC 4-38-7.
9 (4) Administrative fees deposited in the fund under section 1 of
10 this chapter.
11 **(d) The expenses of administering the fund shall be paid from**
12 **the fund.**
13 **(e) The treasurer of state shall invest the money in the fund not**
14 **currently needed to meet the obligations of the fund in the same**
15 **manner that other public money may be invested. Interest that**
16 **accrues from these investments shall be deposited in the fund.**
17 **(f) Money in the fund at the end of a state fiscal year does not**

1 revert to the state general fund.

2 (g) Money in the fund is continuously appropriated to the
3 commission for the purpose of administering this article.

4 SECTION 2. IC 5-1.2-4.5-3 IS REPEALED [EFFECTIVE JULY 1,
5 2020]. Sec. 3: (a) This section applies to any other agreement to which
6 the authority or the state is a party under any provision of the Indiana
7 Code, other than IC 8-15.5, or any extension or any amendment to such
8 an agreement, and that is to be entered into after May 1, 2019.

9 (b) If the proposed agreement, extension, or amendment would
10 increase the amount to be received by the authority or the state by at
11 least one hundred million dollars (\$100,000,000), the authority or the
12 state shall submit the proposed agreement, extension, or amendment to
13 the budget committee established by IC 4-12-1-3 for its review. The
14 budget committee may request that the authority or the state, or both,
15 appear at a public meeting of the budget committee concerning the
16 proposed agreement, extension or amendment. The authority or the
17 state may not enter into the proposed agreement, extension or
18 amendment until after the budget committee has reviewed the proposed
19 agreement, extension or amendment.

20 SECTION 3. [EFFECTIVE UPON PASSAGE] (a) There is
21 appropriated to Purdue University, West Lafayette, seventy-three
22 million dollars (\$73,000,000) from the state general fund for its
23 construction of the College of Veterinary Medicine Teaching
24 Hospital beginning July 1, 2019, and ending June 30, 2021.

25 (b) There is appropriated to Indiana University sixty-two
26 million dollars (\$62,000,000) from the state general fund for its
27 bicentennial repair and rehabilitation plan beginning July 1, 2019,
28 and ending June 30, 2021.

29 (c) There is appropriated to Ball State University fifty-nine
30 million nine hundred thousand dollars (\$59,900,000) from the state
31 general fund for its STEM and Health Professions Facilities Phase
32 III beginning July 1, 2019, and ending June 30, 2021.

33 (d) There is appropriated to Ivy Tech Community College
34 twenty-nine million eight hundred ninety thousand dollars
35 (\$29,890,000) from the state general fund for its Columbus Campus
36 Main Building Replacement beginning July 1, 2019, and ending
37 June 30, 2021.

38 (e) There is appropriated to Indiana State University eighteen
39 million four hundred thousand dollars (\$18,400,000) from the state
40 general fund for its Academic Facility Renovation Phase Two,
41 Dreiser Hall beginning July 1, 2019, and ending June 30, 2021.

42 (f) There is appropriated to the University of Southern Indiana



1 **forty-eight million dollars (\$48,000,000) from the state general**
2 **fund for its Health Professions Classroom Renovation beginning**
3 **July 1, 2019, and ending June 30, 2021.**

4 **(g) Notwithstanding IC 21-33-3, the projects funded in**
5 **subsections (a) through (f) do not require review by the commission**
6 **for higher education or an advisory recommendation by the budget**
7 **committee if the projects were already reviewed by the commission**
8 **for higher education and recommended by the budget committee**
9 **before April 1, 2020.**

10 **(h) This SECTION expires July 1, 2021.**

11 **SECTION 4. An emergency is declared for this act.**
