

## **HOUSE BILL No. 1007**

DIGEST OF HB 1007 (Updated February 9, 2021 5:32 pm - DI 140)

**Citations Affected:** IC 16-18; IC 16-30; IC 16-46.

Synopsis: State health improvement and grant program. Requires the state department of health (department), in consultation with the office of the secretary of family and social services, to study and prepare a plan (plan) to improve the health and behavioral health of Indiana residents. Requires the plan to be submitted to the general assembly. Requires that the department establish and maintain on the department's Internet web site a web page that indicates the performance and progress of the metrics and goals of the most significant areas identified in the plan. Establishes the prevention and addressing of health issues and challenges grant program (grant program). Establishes the prevention and addressing of health issues and challenges grant fund. Requires the department to administer the grant program. Provides requirements for grant proposals. Requires the department to give preference in awarding the grants based on specified criteria. Requires the management performance hub to develop and publish on an Internet web site a web page that tracks Indiana's metrics on the most significant areas of health and behavioral health impacting Indiana residents and demonstrate any progress made in these metrics. Provides that the web page must include specific progress reported by organizations awarded a grant under the grant program.

26	Sec. 1. As used in this chapter, "grant program" refers to the
27	prevention and addressing of health issues and challenges grant
28	program established by section 3 of this chapter.
29	Sec. 2. As used in this chapter, "person" means an individual,
30	employer, employer association, nonprofit organization, for-profit
31	organization, municipality (as defined in IC 36-1-2-11), school
32	corporation, charter school, accredited nonpublic school, research
33	institution, health insurance plan, health insurance ministry, or
34	any combination of these.
35	Sec. 3. The prevention and addressing of health issues and
36	challenges grant program is established to provide grants to
37	eligible entities across the state. The state department shall
38	administer the program.
39	Sec. 4. (a) The prevention and addressing of health issues and
40	challenges grant fund is established for the purpose of distributing
41	money for the grant program. The fund shall be administered by
42	the state department.



1	(b) The fund consists of:
2	(1) money appropriated for the program or to the fund by the
3	general assembly;
4	(2) money received from state or federal grants or programs;
5	and
6	(3) gifts, money, and donations received from any other
7	source, including transfers from other funds or accounts.
8	(c) The expenses of administering the fund shall be paid from
9	money in the fund.
10	(d) The treasurer of state shall invest the money in the fund not
11	currently needed to meet the obligations of the fund in the same
12	manner as other public money may be invested. Interest that
13	accrues from the investments shall be deposited in the fund.
14	(e) Money in the fund at the end of the state fiscal year does not
15	revert to the state general fund or to any other fund in the case of
16	an appropriation made to the program from a fund other than the
17	state general fund. In addition, if there is an appropriation for the
18	program for a state fiscal year, the money appropriated shall be
19	transferred to the fund at the beginning of the state fiscal year for
20	which the appropriation is made.
21	Sec. 5. (a) A person seeking a grant under this chapter must
22	submit a proposal to the state department.
23	(b) A proposal for a grant under this chapter must include the
24	following:
25	(1) Proposed measurable and specific improvement in one (1)
26	or more critical health metrics within a defined cohort. The
27	cohort may be defined by any health, demographic, or
28	geographic criteria, or any combination of these. However, a
29	cohort defined using demographic criteria may include
30	criteria based on employment in a particular industry or
31	having particular job duties.
32	(2) The time frame in which to achieve the proposed
33	measurable improvement or improvements described in
34	subdivision (1). However, the time frame in which an initial
35	proposed measurable improvement is achieved may not be
36	more than two (2) years.
37	Sec. 6. In awarding grants under this chapter, the state
38	department shall give preference to proposals that seek to do any
39	of the following:
40	(1) Focus on chronic health problems.

(2) Involve a combination of persons working in coordination

to achieve a measurable health outcome or outcomes.

1	(3) Leverage additional resources, including any private or
2	philanthropic resources.
3	(4) Demonstrate creative and evidence based methods of

7	Sec. 7. (a) The state department shall determine whether to
8	award a grant under this chapter.
9	(b) Subject to subsection (c), if the state department approves a
10	proposal:
11	(1) the initial grant amount awarded shall not exceed
12	eighty-five percent (85%); or
13	(2) if the proposal approved by the state department will
14	supplement a health initiative that currently receives partial
15	funding from another source, including a Medicaid provider,
16	the initial grant amount awarded shall not exceed seventy-five
17	percent (75%);
18	of the total grant amount approved for the proposal. The state
19	department shall distribute the remaining amount of the approved
20	grant to the grantee when the state department determines that the
21	grantee has achieved the outcome or outcomes in the grant
22	proposal.
23	(c) The state department of health may distribute the initial
24	award amounts described in subsection (b)(1) and (b)(2) over the
25	course of the project that is the subject of the proposal based on
26	achieved objectives.
27	Sec. 8. The management performance hub established by
28	IC 4-3-26-8 shall develop and publish on an Internet web site a web
29	page that tracks Indiana's metrics on the most significant areas of
30	health and behavioral health impacting Indiana residents, as
31	identified by the state department, and demonstrate any progress
32	made in these metrics. The web page must include specific progress
33	reported by organizations awarded a grant under the grant

Page 2, between lines 3 and 4, begin a new paragraph and insert: "SECTION 3. IC 16-30-3-2 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2021]: Sec. 2. (a) The state department, in consultation with the office of the secretary of family and social services, shall study and prepare a plan to improve the health and behavioral health of Indiana residents. The plan must include the following:

- (1) Metrics on the most significant areas of health and behavioral health impacting Indiana residents.
- (2) Goals to improve the health and behavioral health of Indiana residents.
- (b) Before July 1, 2022, the state department shall provide the written plan prepared under this section to the general assembly in an electronic format under IC 5-14-6.
- (c) Before July 1, 2022, the state department shall establish and maintain on the department's Internet web site a web page that indicates the performance and progress of the metrics and goals identified in the plan prepared under subsection (a).
  - (d) This section expires July 1, 2023.".

Page 3, line 18, delete "one (1) year." and insert "**two (2) years.**". Page 4, delete lines 9 through 13, begin a new paragraph and insert:

"Sec. 8. The management performance hub established by IC 4-3-26-8 shall develop and publish on an Internet web site a web page that tracks Indiana's metrics on the most significant areas of health and behavioral health impacting Indiana residents, as identified by the state department, and demonstrate any progress made in these metrics. The web page must include specific progress reported by organizations awarded a grant under the grant program."

Renumber all SECTIONS consecutively.
