

HOUSE BILL No. 1030

DIGEST OF INTRODUCED BILL

Citations Affected: IC 34-30-2-156.4; IC 36-8.

Synopsis: Mental health professionals. Allows a political subdivision, in consultation with the technical assistance center, to contract with mental health providers for the purpose of supplementing existing crisis intervention teams with mental health professionals. Specifies certain eligibility requirements for mental health professionals seeking an appointment to a crisis intervention team. Requires a mental health professional who is appointed to a crisis intervention team to accompany responding law enforcement or police officers to a call involving a mental health or substance abuse disorder crisis. Provides that a law enforcement or police officer (officer) may not be held liable for damages, including punitive damages, for any act or omission related to a mental health professional's contribution to a crisis intervention team or a crisis intervention team response. Specifies that no other person or entity may be held liable for certain damages by reason of an agency relationship with an officer. Defines certain terms.

7 **Chapter 23.5. Crisis Intervention Teams and Mental Health
8 Professionals**

9 **Sec. 1. As used in this chapter, "crisis intervention team" has
10 the meaning set forth in IC 5-2-1-2(7).**

11 **Sec. 2. As used in this chapter, "mental health professional"
12 means a:**

- 13 (1) mental health counselor licensed under IC 25-23.6-8.5;
- 14 (2) psychologist; or
- 15 (3) psychiatrist.

16 **Sec. 3. As used in this chapter, "political subdivision" means a
17 county, township, city, or town.**

18 **Sec. 4. As used in this chapter, "technical assistance center" has
19 the meaning set forth in IC 5-2-21.2-5.**

20 **Sec. 5. A political subdivision, in consultation with the technical
21 assistance center, may contract with a mental health professional
22 for the purpose of supplementing an existing crisis intervention
23 team with an on call mental health professional. A mental health
24 professional described in this section must:**

- 25 (1) have training in the treatment of substance abuse
26 disorders and mental health disorders; and
- 27 (2) possess expertise in one (1) or more of the following areas
28 to be eligible for an appointment to an existing crisis
29 intervention team:

- 30 (A) Trauma informed care.
- 31 (B) Deescalation techniques.
- 32 (C) Crisis communication.

33 **Sec. 6. If an emergency dispatch involves a mental health or
34 substance abuse disorder crisis, the on call mental health
35 professional described in section 5 of this chapter shall, to the
36 extent practicable, accompany responding law enforcement or
37 police officers to the scene for the purpose of providing:**

- 38 (1) onsite guidance to responding officers;
- 39 (2) onsite treatment to persons in crisis;
- 40 (3) coordination and referrals for follow-up care and
41 wraparound services; and
- 42 (4) any other treatment, assistance, or guidance deemed



1 necessary by the mental health professional.
2 **Sec. 7. The technical assistance center:**
3 **(1) shall establish guidelines; and**
4 **(2) may adopt rules under IC 4-22-2;**
5 **in order to implement this chapter.**
6 **Sec. 8. Nothing in this chapter may be construed to authorize**
7 **the exercise of any police power by a mental health professional**
8 **described in section 5 of this chapter.**
9 **Sec. 9. A law enforcement officer or police officer may not be**
10 **held liable for damages, including punitive damages, for any act or**
11 **omission related to a mental health professional's contribution to**
12 **a crisis intervention team or a crisis intervention team response. If**
13 **a law enforcement officer or police officer is not liable for an act or**
14 **omission under this section, no other person or entity incurs**
15 **liability by reason of an agency relationship with the applicable law**
16 **enforcement officer or police officer.**
