DIGEST OF HB 1041 (Updated February 25, 2014 10:38 am - DI 84)

Citations Affected: IC 33-42.

Synopsis: Oaths and acknowledgment of documents. Allows the adjutant general of the Indiana National Guard, specific active duty members, reserve duty members, or civilian employees of the Indiana National Guard designated by the adjutant general of the Indiana National Guard, to subscribe and administer oaths and take acknowledgments of all documents related to the service of an active or reserve duty member of the Indiana National Guard.

Effective: July 1, 2014.

ENGROSSED HOUSE BILL No. 1041

A BILL FOR AN ACT to amend the Indiana Code concerning military and veterans.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 33-42-4-1 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2014]: Sec. 1. The following may
3 subscribe and administer oaths and take acknowledgments of all
4 documents pertaining to all matters where an oath is required:
5 (1) Notaries public.
6 (2) Justices and judges of courts, in their respective jurisdictions.
7 (3) The secretary of state.
8 (4) The clerk of the supreme court.
9 (5) Mayors, clerks, clerk-treasurers of towns and cities, and
10 township trustees, in their respective towns, cities, and townships.
11 (6) Clerks of circuit courts and master commissioners, in their
12 respective counties.
13 (7) Judges of United States district courts of Indiana, in their
14 respective jurisdictions.
15 (8) United States commissioners appointed for any United States
16 district court of Indiana, in their respective jurisdictions.

- 1 (9) A precinct election officer (as defined in IC 3-5-2-40.1) and
- 2 an absentee voter board member appointed under IC 3-11-10, for
- 3 any purpose authorized under IC 3.
- 4 (10) A member of the Indiana election commission, a co-director
- 5 of the election division, or an employee of the election division
- 6 under IC 3-6-4.2.
- 7 (11) County auditors, in their respective counties.
- 8 (12) Any member of the general assembly anywhere in Indiana.
- 9 **(13) The adjutant general of the Indiana National Guard,**
- 10 **specific active duty members, reserve duty members, or**
- 11 **civilian employees of the Indiana National Guard designated**
- 12 **by the adjutant general of the Indiana National Guard, for**
