DIGEST OF HB 1045 (Updated January 14, 2016 9:35 am - DI 116)

Citations Affected: IC 20-20.

Synopsis: School efficiency grants. Establishes the school efficiency grant program for the purpose of providing grants to school corporations for costs associated with implementing efficiency and cost effective measures. Establishes the school efficiency grant fund.

Effective: July 1, 2016.

HOUSE BILL No. 1045

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 20-20-42 IS ADDED TO THE INDIANA CODE

3	JULY 1, 2016]:
4	Chapter 42. School Efficiency Grant Program and Fund
5	Sec. 1. As used in this chapter, "applicant" means a school
6	corporation that applies for a school efficiency grant under this
7	chapter.
8	Sec. 2. As used in this chapter, "fund" refers to the school
9	efficiency grant fund established by section 3 of this chapter.
0	Sec. 3. (a) The school efficiency grant fund is established for the
1	purpose of providing grants to school corporations for costs
2	associated with implementing efficiency and cost effective
3	measures.
4	(b) The fund consists of:
5	(1) appropriations made by the general assembly; and
6	(2) gifts, grants, devises, or bequests made to the state to
7	achieve the purposes of the fund.

1	(c) The state board shall administer the fund.
2	(d) Money in the fund at the end of a state fiscal year does not
3	revert to the state general fund.
4	(e) The treasurer of state shall invest the money in the fund not
5	currently needed to meet the obligations of the fund in the same
6	manner as other public funds may be invested.
7	Sec. 4. The state board, in consultation with the department,
8	shall receive and consider an application from a school corporation
9	for a school efficiency grant under this chapter.
10	Sec. 5. (a) To qualify for a grant under this chapter, a school
11	corporation must:
12	(1) apply for the grant on a form supplied by the state board;
13	(2) submit a plan to the state board that includes:
14	(A) information on the efficiency and cost effective
15	measures the school corporation is proposing to
16	implement; and
17	(B) the cost associated with implementing the measures
18	described in clause (A); and
19	(3) meet any other criteria established by the state board, in
20	consultation with the department.
21	(b) Two (2) or more school corporations may apply for a grant
22	together on one (1) application if the plan is proposing to
23	implement efficiency and cost effective measures that would affect
24	the two (2) or more school corporations applying for the grant.
25	(c) The state board, in consultation with the department, may
26	require an applicant to include a cost analysis study of the
27	proposed plan.
28	(d) The state board, in consultation with the department, shall
29	establish criteria for the:
30	(1) selection of plans submitted under subsection (a); and
31	(2) awarding of grants under this chapter.
32	Sec. 6. In determining whether to award a school efficiency
33	grant to an applicant under this chapter, the state board, in
34	consultation with the department, shall consider whether the plan
35	submitted by the applicant under section 5 of this chapter will do
36	one (1) or more of the following:
37	(1) Reduce administrative costs by merging or consolidating
38	administrative services within a school corporation or among
39	two (2) or more school corporations.
40	(2) Reduce the duplication of programs or services within a
41	school corporation or among two (2) or more school
42	corporations.



1	(3) Increase cost efficiencies relating to the use of school
2	facilities.
3	(4) Reduce debt of one (1) or more school corporations.
4	(5) Establish any other measure that would significantly
5	reduce costs related to the provision of educational services,
6	special education services, or any other service provided
7	within a school corporation or among two (2) or more school
8	corporations.
9	Sec. 7. The state board, in consultation with the department,
10	may award a school efficiency grant to an applicant that meets the
11	requirements under this chapter.
12	Sec. 8. (a) The state board, in consultation with the department,
13	shall establish the terms and conditions for awarding a grant to an
14	applicant under this chapter, including requirements to ensure that
15	the applicant complies with the grant terms and conditions.
16	(b) The state board, in consultation with the department, shall
17	establish parameters or requirements that an applicant must meet
18	in order for the applicant to use a part of a grant awarded under
19	this chapter to pay for consulting or fees or charges by a third
20	party or consultant to develop the applicant's plan.
21	(c) A school corporation is not entitled to a grant under this
22	chapter for cost efficiencies of the school corporation that are also
23	included in a guaranteed savings contract under IC 36-1-12.5.
24	Sec. 9. (a) Subject to subsection (b), the state board, in
25	consultation with the department, shall determine the amount of
26	each grant awarded under this chapter.
27	(b) The state board, in consultation with the department, shall
28	establish written guidelines for determining the amount of a grant
29	awarded to an applicant based on the amount of cost savings to the
30	applicant as a result of implementing the plan submitted under
31	section 5 of this chapter. However, a grant awarded under this
32	chapter for implementation of a plan may not exceed five hundred
33	thousand dollars (\$500,000).
34	Sec. 10. (a) Except as provided in subsection (b), a school
35	corporation that receives a grant under this chapter must use the
36	amount of the grant for the costs associated with implementing the
37	plan submitted under section 5 of this chapter.
38	(b) A school corporation that receives a grant under this chapter
39	may use the amount of the grant awarded to pay any costs of

preparing a cost analysis study associated with a plan submitted
