DIGEST OF HB 1045 (Updated February 27, 2020 9:54 am - DI 125)

Citations Affected: IC 1-1.

Synopsis: Display of flag. Requires a flag to be displayed at each state office building, the state cemetery, and each veterans cemetery managed by the Indiana department of veterans' affairs.

Effective: Upon passage.

ENGROSSED HOUSE BILL No. 1045

A BILL FOR AN ACT to amend the Indiana Code concerning military and veterans.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 1-1-13 IS ADDED TO THE INDIANA CODE AS
2	A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE UPON
3	PASSAGE]:
4	Chapter 15. Display of Flag
5	Sec. 1. As used in this chapter, "Honor and Remember flag"
6	means the Honor and Remember, Inc., flag.
7	Sec. 2. The Honor and Remember flag is designated as the
8	symbol of our state's concern and commitment to honor and
9	remember the lives of all members of the United States armed
0	forces who lost their lives while serving or as a result of service in
1	the armed forces of the United States and their families.
2	Sec. 3. The symbolism of the Honor and Remember flag is as
3	follows:
4	(1) The red field represents the blood spilled by brave men
5	and women in America's military throughout our history
6	who willingly gave their lives so that we all would remain free
7	(2) The white border beneath and surrounding the gold star

1	recognizes the purity of that sacrifice. There is no greater
2	price an American can pay than to give his or her life in
3	service to our country.
4	(3) The blue star represents active service in military conflict.
5	This symbol originated in World War I, but on this flag it
6	signifies service through all generations from the American
7	Revolution to present day.
8	(4) The gold star signifies the ultimate sacrifice as a warrior
9	in active service who will not return home. The gold color
10	reflects the value of the life given.
11	(5) The folded flag signifies the final tribute to an individual
12	life that a family sacrificed and gave to the nation.
13	(6) The flame is an eternal reminder of the spirit that has
14	departed this life yet burns on in the memory of all who knew
15	and loved the fallen hero.
16	Sec. 4. The American flag or the Honor and Remember flag
17	shall be displayed at:
18	(1) each state office building;
19	(2) the state cemetery established by IC 10-17-11-4; and
20	(3) each veterans cemetery managed by the Indiana
21	department of veterans' affairs; and
22	may be displayed at all levels of government during the entire
23	month of May annually.
24	Sec. 5. The Honor and Remember flag may be displayed at any
25	of the entities listed in section 4 of this chapter at any time.
26	SECTION 2. An emergency is declared for this act.
