ENGROSSED HOUSE BILL No. 1053

DIGEST OF HB 1053 (Updated March 11, 2015 2:21 pm - DI 110)

Citations Affected: IC 7.1-3.

Synopsis: Drink sales at microbrewery, farm winery, and artisan distillery. Allows any combination of a microbrewery, farm winery, and an artisan distillery that occupy the same building to sell by the glass the microbrewery's beer, the farm winery's wine, and the artisan distillery's liquor from the same service bar, without a structure separating the service of wine, the service of beer, and the service of liquor. Provides that the restrictions and provisions of an artisan distillery's, microbrewery's, or farm winery's permit governing the sale or service of alcoholic beverages apply to the sale and service of the alcoholic beverage.

Effective: July 1, 2015.

ENGROSSED HOUSE BILL No. 1053

A BILL FOR AN ACT to amend the Indiana Code concerning alcohol and tobacco.

Be it enacted by the General Assembly of the State of Indiana:

Page 2, line 7, after "holds" delete "a" and insert "**any combination of a farm winery permit, a brewery permit under IC 7.1-3-2-7(5), and an artisan distiller's permit,**".

Page 2, delete line 8.

Page 2, line 10, delete "and".

Page 2, line 11, after ";" insert "**and**

(3) an artisan distillery's liquor;".

Page 2, line 13, delete "wine and the service of beer." and insert "**wine, the service of beer, and the service of liquor.**".

(c) Except as provided in this chapter, the restrictions and provisions of a permittee's permit governing the sale or service of the alcoholic beverage that is the subject of the permit apply to the sale and service of the alcoholic beverage under this chapter.
