## **HOUSE BILL No. 1070**

#### DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 9-13-2-177.4; IC 9-21-8.

**Synopsis:** Distracted driving. Provides that a person may not hold or use a telecommunications device in the driver's seat of a motor vehicle while the motor vehicle is in motion unless the device is used in conjunction with hands free or voice operated technology or used to call 911 to report a bona fide emergency. Removes prohibitions on typing, transmitting, or reading a text message or an electronic mail message while operating a moving motor vehicle. Makes conforming changes.

Effective: July 1, 2020.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

19	(3) extract or otherwise download information from a
20	telecommunications device for a violation of this section unless:
21	(A) the police officer has probable cause to believe that the
22	telecommunications device has been used in the commission
23	of a crime;
24	(B) the information is extracted or otherwise downloaded
25	under a valid search warrant; or
26	(C) otherwise authorized by law.
