DIGEST OF HB 1070 (Updated January 25, 2024 10:34 am - DI 148)

Citations Affected: IC 12-21.

**Synopsis:** Mental health grants. Allows the division of mental health and addiction to award mental health grants to for-profit community mental health organizations if a nonprofit organization does not qualify for the grant.

Effective: July 1, 2024.

#### HOUSE BILL No. 1070

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

1SECTION 1. IC 12-21-5-9 IS ADDED TO THE INDIANA CODE2AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY31, 2024]: Sec. 9. Except as required by federal law, the division may4award a grant that is administered by the division for mental5health care and services to a for-profit community mental health6organization if a nonprofit organization does not qualify for the7grant.
