## ENGROSSED HOUSE BILL No. 1070

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

*Be it enacted by the General Assembly of the State of Indiana:*

1           SECTION 1. IC 12-21-5-9 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2024]: **Sec. 9. Except as required by federal law, the division may**  
4 **award a grant that is administered by the division for mental**  
5 **health care and services to a for-profit community mental health**  
6 **organization if a nonprofit organization does not qualify for the**  
7 **grant.**
