HOUSE BILL No. 1071

DIGEST OF HB 1071 (Updated January 18, 2022 8:49 am - DI 140)

Citations Affected: IC 10-18.

Synopsis: Report on global war on terrorism monument. Requires the Indiana war memorials commission (IWMC) to propose the construction of a suitable monument to the men and women of Indiana who lost their lives in the global war on terrorism. Requires the IWMC to conduct five public meetings concerning the proposed monument. Provides that a meeting must be held in Indianapolis and in each of the four regions of Indiana. Requires the IWMC to submit a detailed description of the proposed monument to the legislative council and the governor before November 1, 2022.

Effective: Upon passage.

HOUSE BILL No. 1071

A BILL FOR AN ACT to amend the Indiana Code concerning public safety.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 10-18-10 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]:

4 **Chapter 10. Global War on Terrorism Monument**

5 **Sec. 1. As used in this chapter, "commission" refers to the**
6 **Indiana war memorials commission established by IC 10-18-1-2.**

7 **Sec. 2. As used in this chapter, "global war on terrorism" refers**
8 **to the conflicts fought around the world to suppress and deter**
9 **terrorism after September 11, 2001, and before September 1, 2021.**

10 **Sec. 3. The commission shall propose the construction of a**
11 **suitable monument to the men and women of Indiana who lost**
12 **their lives in the global war on terrorism.**

13 **Sec. 4. Before November 1, 2022, the commission shall conduct**
14 **five (5) public meetings concerning the proposal required by**
15 **section 3 of this chapter. The commission shall meet in Indianapolis**
16 **and at a central location within each of the following regions:**

17 **(1) Northwest Indiana.**

1 **(2) Northeast Indiana.**
2 **(3) Southeast Indiana.**
3 **(4) Southwest Indiana.**
4 **Sec. 5. Before November 1, 2022, the commission shall submit**
5 **a detailed description of a monument proposed in accordance with**
6 **section 3 of this chapter to the legislative council in an electronic**
7 **format under IC 5-14-6 and to the governor. The submitted**
8 **description must include the following information:**
9 **(1) The location of the proposed monument.**
10 **(2) A rendering of the proposed monument.**
11 **(3) The estimated cost of constructing and maintaining the**
12 **proposed monument.**
13 **Sec. 6. The commission may accept any of the following in**
14 **carrying out this chapter:**
15 **(1) Organizational and logistical assistance from a bona fide**
16 **veterans organization (as defined by IC 4-32.3-2-11),**
17 **including the use of a facility owned and maintained by a bona**
18 **fide veterans organization.**
19 **(2) Organizational and logistical assistance from the Indiana**
20 **national guard, including the use of a facility owned and**
21 **maintained by the Indiana national guard.**
22 **(3) Donations, gifts, bequests, and devises for the**
23 **commission's use in constructing and maintaining a**
24 **monument under this chapter.**
25 **(4) Volunteer assistance to carry out any task assigned by the**
26 **commission or the superintendent employed by the**
27 **commission.**
28 **SECTION 2. An emergency is declared for this act.**
