DIGEST OF INTRODUCED BILL

Citations Affected: IC 3-11-10-23; IC 3-11.5-4-17.

Synopsis: Absentee ballots cast before death. Requires that an absentee ballot marked and forwarded by a voter who subsequently dies be counted if the absentee ballot would otherwise be entitled to be counted if the voter had not died.

Effective: Upon passage.
