

HOUSE BILL No. 1088

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-27.

Synopsis: School buses. Provides that the state school bus committee shall adopt rules to require that each new school bus operated by or on behalf of a school corporation bear the name of the school district (rather than the district's number) on the back of the school bus. Provides that an individual who is or intends to become a school bus driver must obtain a physical examination certificate by an individual who is registered in the Federal Motor Carrier Safety Administration's National Registry of Certified Medical Examiners. Provides that a school corporation shall determine how a certified medical examiner is chosen for the physical examination and who must pay for the physical examination.

Effective: July 1, 2014.

HOUSE BILL No. 1088

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-27-3-5, AS ADDED BY P.L. 1-2005, SECTION
2 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,
3 2014]: Sec. 5. The committee shall adopt and enforce rules under
4 IC 4-22-2 to require that each new school bus operated by or on behalf
5 of a school corporation bear the ~~number name~~ of the school district on
6 the back of the school bus in black letters that are at least four (4)
7 inches and not more than six (6) inches high.
8 SECTION 2. IC 20-27-8-4, AS AMENDED BY P.L.82-2009,
9 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
10 JULY 1, 2014]: Sec. 4. An individual who is or intends to become a
11 school bus driver must obtain a physical examination certificate stating
12 that the individual possesses the physical characteristics required by
13 section 1(a)(7) of this chapter. The certificate shall be made by a
14 ~~physician who is licensed in Indiana or a state bordering Indiana~~ after
15 ~~the physician~~ **an individual who is registered in the Federal Motor**
16 **Carrier Safety Administration's National Registry of Certified**



1 **Medical Examiners after the certified medical examiner** has
2 conducted a physical examination of the school bus driver or
3 prospective school bus driver. ~~The physician shall be chosen by the~~
4 ~~school bus driver or prospective driver, who shall pay for the~~
5 ~~examination. The school corporation shall determine how the~~
6 **certified medical examiner is chosen for the physical examination**
7 **and who must pay for the physical examination.**
