

HOUSE BILL No. 1089

DIGEST OF INTRODUCED BILL

Citations Affected: IC 6-3.6-9-12; IC 10-17-1.

Synopsis: Veteran service officers. Creates the position of district service officer. Requires the veterans' affairs commission (commission) to establish certification requirements for district service officers. Requires the commission to create six geographic districts in Indiana and appoint a district service officer for each district. Specifies the role and responsibilities of district service officers. Requires a portion of local income taxes to be withheld from cities and counties that fail to enforce accreditation and reaccreditation requirements for city and county service officers.

Effective: July 1, 2016.

HOUSE BILL No. 1089

A BILL FOR AN ACT to amend the Indiana Code concerning public safety.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 6-3.6-9-12, AS ADDED BY P.L.243-2015,
2 SECTION 10, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2016]: Sec. 12. **(a) Except as provided in subsection (b),**
4 one-twelfth (1/12) of each adopting county's certified distribution for
5 a calendar year shall be distributed from its trust account established
6 under this chapter to the appropriate county treasurer on the first
7 regular business day of each month of that calendar year.
8 **(b) If the Indiana veterans' affairs commission has certified to**
9 **the auditor of state and the budget agency that a county or city is**
10 **not in compliance with the requirements of IC 10-17-1, one-fourth**
11 **(1/4) of the part of the certified distribution that would be**
12 **distributed to the county civil taxing unit shall be withheld by the**
13 **auditor of state until the city or county has complied with**
14 **IC 10-17-1.**
15 **(c) If a part of a distribution is withheld under subsection (b)**
16 **and the city or county subsequently complies with IC 10-17-1, the**
17 **auditor of state shall distribute to the county civil taxing unit the**



1 **amount of the distribution that was previously withheld, without**
 2 **interest for the period during which the distribution was withheld.**

3 **(d) A withholding made under subsection (b) shall not affect a**
 4 **distribution to any unit other than the county civil taxing unit.**

5 SECTION 2. IC 10-17-1-4, AS AMENDED BY P.L.169-2013,
 6 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 7 JULY 1, 2016]: Sec. 4. The commission shall do acts necessary or
 8 reasonably incident to the fulfillment of the purposes of this chapter,
 9 including the following:

10 (1) Adopt rules under IC 4-22-2 to administer this chapter.

11 (2) Advise the veterans' state service officer in problems
 12 concerning the welfare of veterans.

13 (3) Determine general administrative policies within the
 14 department.

15 (4) Establish standards for certification of **district**, county, and
 16 city service officers.

17 (5) Establish and administer a written examination for renewal of
 18 the certification of **district**, county, and city service officers.

19 **(6) Establish six (6) districts in Indiana to be staffed by a**
 20 **district service officer in each of the districts.**

21 **(7) Appoint a district service officer to each of the six (6)**
 22 **districts established under subdivision (6).**

23 SECTION 3. IC 10-17-1-9.5 IS ADDED TO THE INDIANA CODE
 24 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
 25 1, 2016]: Sec. 9.5. (a) A district service officer must do the
 26 following:

27 (1) Serve in one (1) of the six (6) geographic districts
 28 established by the commission under section 4(6) of this
 29 chapter.

30 (2) Provide training and assistance to all city and county
 31 service officers located in the district service officer's district.

32 (3) Provide accreditation and reaccreditation opportunities
 33 for city and county service officers located in the district
 34 service officer's district.

35 (4) Perform community outreach services for veterans and
 36 veterans' families.

37 (5) Perform any other service deemed necessary by the
 38 commission.

39 (b) A district service officer must live in the district served by
 40 the officer.

41 (c) District service officers shall report to the director of
 42 veterans' affairs.



1 SECTION 4. IC 10-17-1-10, AS AMENDED BY P.L.169-2013,
2 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2016]: Sec. 10. (a) Within thirty (30) days of their
4 appointment, new **district**, county, or city service officers must attend
5 a new service officer orientation presented by the Indiana department
6 of veterans' affairs and, according to the standards established under
7 section 4(4) of this chapter, become certified to assist veterans and
8 their dependents and survivors. The curriculum for the new service
9 officer orientation presented under this subsection shall be determined
10 by the director.

11 (b) Within one (1) year of appointment, new service officers must
12 attend a course presented by a national organization and become
13 accredited to represent veterans.

14 (c) An individual employed as a **district**, county, or city service
15 officer under this chapter on July 1, 2013, is required to become
16 accredited not later than July 1, ~~2015~~, **2016**, to represent veterans.

17 (d) Annually, all **district**, county, or city service officers shall
18 undergo a course of training to adequately address problems of
19 discharged veterans in the service officer's **district**, county, or city,
20 including a thorough familiarization with laws, rules, and regulations
21 of the federal government and the state that affect benefits to which the
22 veterans and dependents of the veterans are entitled. After a service
23 officer has undergone this sustainment training and successfully passed
24 a written test, the service officer shall be recertified by the director to
25 assist veterans for the following year.

26 **(e) If a city or county service officer resigns or is terminated**
27 **from the service officer position, the city or county shall appoint a**
28 **new service officer not more than thirty (30) days after the**
29 **resignation or termination.**

30 **(f) Except as provided in subsection (e), a county that fails to**
31 **comply with this chapter shall be penalized as provided in**
32 **IC 6-3.6-9-12(b).**
