# HOUSE BILL No. 1090

DIGEST OF INTRODUCED BILL

Citations Affected: IC 8-6-7.5-2.5.

**Synopsis:** Railroad crossings. Requires a railroad corporation to inform the local law enforcement authority of a blocked railroad-highway grade crossing in certain instances.

Effective: July 1, 2019.

### HOUSE BILL No. 1090

A BILL FOR AN ACT to amend the Indiana Code concerning transportation.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 8-6-7.5-2.5 IS ADDED TO THE INDIANA CODE
2	AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3	1,2019]: Sec. 2.5. (a) As used in this section, "emergency responder
4	agency" means the following:
5	(1) A fire department established under IC 36-8-2-3.
6	(2) A volunteer fire department (as defined in IC 36-8-12-2).
7	(3) A law enforcement agency of a political subdivision.
8	(4) An emergency medical services agency of a political

10	(b) A railroad corporation shall notify the local law enforcement
11	authority (as defined in IC 11-8-8-2) having jurisdiction over the
12	area of the applicable railroad-highway grade crossing each time
13	a train, railroad car, or engine will obstruct public travel at a
14	railroad-highway grade crossing for a period in excess of ten (10)
15	minutes.
16	(c) A notice described under subsection (b) must include the
17	approximate time that the railroad-highway grade crossing will be

2 (d) When a local law enforcement authority receives a notice
3 from a railroad corporation under subsection (b), the local law
4 enforcement authority must notify as soon as practicable any
