#### HOUSE BILL No. 1096

DIGEST OF HB 1096 (Updated January 24, 2018 12:14 pm - DI 55)

Citations Affected: IC 13-11; IC 13-18.

**Synopsis:** Construction requirements of MS4 operators. Prohibits the person responsible for development, implementation, or enforcement of the requirements established by a city, town, conservancy district, or other public or private entity that owns, operates, or maintains a regulated municipal separate storm sewer system (MS4) from imposing construction site run-off control requirements more stringent than the construction site run-off control requirements established by the general permit authorized by the article of the Indiana administrative code on the National Pollutant Discharge Elimination System (NPDES) general permit rule program.

Effective: July 1, 2018.

A BILL FOR AN ACT to amend the Indiana Code concerning environmental law.

Be it enacted by the General Assembly of the State of Indiana:

1 National Pollutant Discharge Elimination System (NPDES) general 2 permits. 3 Sec. 2. As used in this chapter, "construction site run-off control 4 requirements" means requirements intended to prevent erosion 5 and sediment runoff from construction sites by mandating the use 6 of anchored mulch, open vegetated swales and buffer strips, the 7 minimization of land disturbance and surface imperviousness, and 8 similar measures. 9 Sec. 3. As used in this chapter, "MS4 operator" means the 10 person responsible for development, implementation, or enforcement of the requirements established by a city, town, 11 12 conservancy district, or other public or private entity that: 13 (1) owns, operates, or maintains a regulated municipal 14 separate storm sewer system (MS4); and 15 (2) is required by the general permit authorized by 327 16 IAC 15 to develop a storm water quality management plan 17 that includes a commitment to develop an erosion and 18 sediment control program for construction activities that 19 disturb one (1) or more acres of land within the MS4 area. 20 Sec. 4. An MS4 operator may not impose construction site 21 run-off control requirements that are more stringent than the 22 construction site run-off control requirements established by the 23 general permit authorized by 327 IAC 15.
