DIGEST OF INTRODUCED BILL

Citations Affected: IC 34-30-2-151.9; IC 35-48-4-18.

Synopsis: Cannabidiol treatment for epilepsy. Provides that a person who possesses or uses cannabidiol oil for the treatment of intractable epilepsy is not subject to criminal penalties for the possession or use of the cannabidiol oil if certain conditions are met. Provides civil, criminal, and administrative immunity for a physician who recommends, possesses, dispenses, or administers cannabidiol oil in the treatment of intractable epilepsy.

Effective: July 1, 2016.

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

8	1, 2016]: Sec. 18. (a) As used in this section, "cannabidiol oil"
9	means an extract from a hemp plant in an oral suspension or oil
10	that:
11	(1) is composed of not more than three-tenths percent (0.3%)
12	total tetrahydrocannabinol (THC) by weight;
13	(2) is composed of at least fifteen (15) times more cannabidiol
14	than total tetrahydrocannabinol (THC) by weight; and
15	(3) contains no other controlled substance.
16	(b) Notwithstanding any other law, an individual who possesses
17	or uses cannabidiol oil is not subject to the penalties for the

1	possession or use of the cannabidiol oil if the following conditions
2	are met:
3	(1) The individual has intractable epilepsy.
4	(2) The individual uses the cannabidiol oil only to treat
5	intractable epilepsy.
6	(3) The individual has a written recommendation for the use
7	of cannabidiol oil from a physician who is licensed to practice
8	medicine or osteopathic medicine in Indiana or by the board
9	or licensing agency of another state.
10	(c) Notwithstanding any other law, an individual who possesses
11	and administers cannabidiol oil is not subject to the penalties for
12	the possession or the administering of the cannabidiol oil if the
13	following conditions are met:
14	(1) The individual is the parent, legal guardian, health care
15	representative, or custodian of an individual who has
16	intractable epilepsy.
17	(2) The individual possesses and administers the cannabidiol
18	oil only to treat the individual with intractable epilepsy.
19	(3) The individual with intractable epilepsy has a written
20	recommendation for the use of cannabidiol oil from a
21	physician who is licensed to practice medicine or osteopathic
22	medicine in Indiana or by the board or licensing agency of
23	another state.
24	(d) A physician who:
25	(1) issues a written recommendation for an individual under
26	subsection (b);
27	(2) possesses or dispenses cannabidiol oil for an individual
28	under subsection (b) or (c); or
29	(3) administers cannabidiol oil to an individual under
30	subsection (c);
31	is immune from civil, criminal, and administrative liability for the
32	recommendation, possession, administration, or dispensing of
33	cannabidiol oil in the treatment of a patient with intractable
34	epilepsy.
