HOUSE BILL No. 1109

DIGEST OF INTRODUCED BILL

Citations Affected: IC 25-1-9.3-6; IC 25-26-24-17.

Synopsis: INSPECT program reporting. Amends the definition of "prescription" for purposes of electronically transmitted prescriptions for controlled substances. Provides that a dispenser who is also authorized to prescribe ephedrine, pseudoephedrine, or a controlled substance is required only to report to the Indiana scheduled prescription electronic collection and tracking (INSPECT) program actual dispensations within 24 hours of the dispensation. Voids a rule that prohibits the transfer of Schedule II controlled substance prescriptions.

Effective: July 1, 2021.

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

18	(K) Other data required by the board.
19	(2) The information required to be transmitted under this section
20	must be transmitted not more than twenty-four (24) hours after the
21	date on which ephedrine, pseudoephedrine, or a controlled
22	substance is dispensed. However, if the dispenser's pharmacy is
23	closed the day following the dispensing, the information must be
24	transmitted by the end of the next business day. A dispenser who
25	is also authorized to prescribe is required only to report
26	actual dispensations within twenty-four (24) hours of the
27	dispensation.
28	(3) A dispenser shall transmit the information required under this
29	section by:
30	(A) uploading to the INSPECT Internet web site; or
31	(B) another electronic method that meets specifications
32	prescribed by the board.
33	(4) The board may require that prescriptions for ephedrine,
34	pseudoephedrine, or controlled substances be written on a one (1)
35	part form that cannot be duplicated. However, the board may not
36	apply such a requirement to prescriptions filled at a pharmacy
37	with a Category II permit (as described in IC 25-26-13-17) and
38	operated by a hospital licensed under IC 16-21, or prescriptions
39	ordered for and dispensed to bona fide enrolled patients in
40	facilities licensed under IC 16-28. The board may not require
41	multiple copy prescription forms for any prescriptions written.

The board may not require different prescription forms for any

individual drug or group of drugs. Prescription forms required
under this subdivision must be approved by the Indiana board of
pharmacy created by IC 25-26-13-3.

(5) The costs of the program.

- (6) As part of the information to be completed in the data base and, if available, an entry where a dispenser indicates that a patient is participating in a pain management contract with a designated practitioner.
- (b) The board shall consider the recommendations of the committee concerning the INSPECT program.
- (c) This subsection applies only to a retail pharmacy. A pharmacist, pharmacy technician, or person authorized by a pharmacist to dispense ephedrine, pseudoephedrine, or a controlled substance may not dispense ephedrine, pseudoephedrine, or a controlled substance to a person who is not personally known to the pharmacist, pharmacy technician, or person authorized by a pharmacist to dispense a controlled substance unless the person taking possession of the ephedrine, pseudoephedrine, or controlled substance provides documented proof of the person's identification to the pharmacist, pharmacy technician, or person authorized by a pharmacist to dispense ephedrine, pseudoephedrine, or a controlled substance.

SECTION 3. [EFFECTIVE JULY 1, 2021] (a) 856 IAC 1-32-2(d) is void. The publisher of the Indiana Administrative Code and Indiana Register shall remove this subsection from the Indiana Administrative Code.

(b) This SECTION expires July 1, 2022.
