HOUSE BILL No. 1114

DIGEST OF HB 1114 (Updated February 4, 2021 11:21 am - DI 92)

Citations Affected: IC 22-13.

Synopsis: Residential building design elements. Prohibits a municipality from regulating design elements of residential structures. Specifies certain exclusions from this prohibition. Provides that any rule, ordinance, or other regulation that conflicts with the prohibition is void. Provides that a person aggrieved by a violation of the bill's provisions may file, in a court having jurisdiction, a petition to obtain an injunction against the violation.

Effective: Upon passage.

HOUSE BILL No. 1114

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 22-13-2-3.6 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: **Sec. 3.6. (a) This section does not apply to the**
4 **following:**
5 (1) **A structure located in an area designated as a local**
6 **historic district under applicable state law.**
7 (2) **A structure located in an area designated as a historic**
8 **district on the National Register of Historic Places.**
9 (3) **A structure designated as a local, state, or national historic**
10 **landmark.**
11 (4) **A structure located on property that is covered by rules,**
12 **covenants, conditions and restrictions, or other governing**
13 **documents (as defined in IC 32-25.5-2-3) of a homeowners**
14 **association.**
15 (5) **A structure owned or operated by a municipality.**
16 (6) **A regulation adopted as a condition for participation in**
17 **the National Flood Insurance Program.**

- 1 (7) A regulation or standard established by a federal or state
2 agency as a condition for participation in a federal or state

- 4 (8) A regulation or standard adopted under IC 22-13-2-2 by

- 7 (b) Except as provided in subsection (c), as used in this section,
8 "design elements", with respect to a structure, means:
- 9 (1) exterior building color;
- 10 (2) type or style of exterior cladding material;
- 11 (3) style or material of roof structures, roof pitches, or
12 porches;
- 13 (4) exterior nonstructural architectural ornamentation;
- 14 (5) location, design, placement, or architectural styling of
15 windows and doors, including garage doors and garage
16 structures;
- 17 (6) the number and types of rooms; and
- 18 (7) the minimum square footage of a structure.
- 19 (c) For purposes of this section, "design elements" do not
20 include:
- 21 (1) the height, bulk, orientation, or location of a structure or
22 lot; or
- 23 (2) buffering or screening used to:
- 24 (A) minimize visual impacts;
- 25 (B) mitigate the impacts of light and noise; or
- 26 (C) protect the privacy of neighbors.
- 27 (d) As used in this section, "municipality" refers to a county,
28 city, or town.
- 29 (e) As used in this section, "residential structure" refers to:
- 30 (1) a Class 1 structure with an occupancy classification of
31 Residential Group R; or
- 32 (2) a Class 2 structure.
- 33 (f) A municipality shall not regulate design elements of
34 residential structures.
- 35 (g) Any rule, ordinance, or other regulation that conflicts with
36 this section is void.
- 37 (h) A person aggrieved by an action in violation of this section
38 may file, in a circuit or superior court having jurisdiction, a
39 petition to obtain an injunction against a violation of this section by
40 a municipality.
- 41 SECTION 2. An emergency is declared for this act.
