DIGEST OF INTRODUCED BILL

Citations Affected: IC 12-15-5-17.

Synopsis: Medicaid nursing facility services. Extends the prohibition on the office of Medicaid policy and planning from including certain Medicaid recipients who receive nursing facility services in a Medicaid risk based managed care program or a capitated managed care program through December 31, 2021. Includes Medicaid recipients who participate in certain waivers or reside in an intermediate care facility for individuals with intellectual disabilities setting in the prohibition of being placed into a risk based managed care program or capitated managed care program.

Effective: July 1, 2019.
