DIGEST OF HB 1123 (Updated April 11, 2019 4:07 pm - DI 101)

Citations Affected: IC 24-4.7; IC 24-5.

Synopsis: Telephone solicitation. Provides that the exemption from the state's "do not call" statute for insurance producers applies only if: (1) the producer; or (2) the insurer on whose behalf the producer is calling; has an established business relationship with the consumer. Adds to the list of telephone calls that are exempt from the "do not call" statute any telephone call made to a consumer by: (1) a financial

institution; or (2) a person licensed by the department of financial institutions to engage in first lien mortgage transactions or consumer credit transactions; that has an established business relationship with the consumer. In addition to requiring the consumer protection division of the attorney general's office (division) to notify Indiana residents of the right of any eligible consumer to place a telephone number on the state's "do not call" listing, requires the division to notify residents of the following: (1) The prohibition under federal law against a person making any call using an: (A) automatic telephone dialing system; or (B) artificial or prerecorded voice; to any telephone number assigned to a mobile telecommunications service. (2) The prohibition under federal law against a person initiating any telephone call to any residential telephone line using an artificial or prerecorded voice to deliver a message without the prior consent of the called party. (3) Information concerning the placement of a telephone number on the National Do Not Call Registry operated by the Federal Trade Commission. Allows the division to use the consumer protection division telephone solicitation fund (fund) to: (1) administer the statutes concerning: (A) the registration of telephone solicitors; and (B) the regulation of automatic dialing machines; and (2) reimburse county prosecutors for expenses incurred in extraditing violators of these and other state and federal statutes concerning telephone solicitations. (Current law provides that the fund may only be used to administer: (1) the state's "do not call" statute; (2) the federal statute concerning restrictions on the use of telephone equipment; and (3) the state statute concerning misleading or inaccurate caller identification.) Provides that certain civil penalties recovered by the attorney general for violations of the statutes concerning: (1) the registration of telephone solicitors; and (2) the regulation of automatic dialing machines; shall be deposited in the consumer protection division telephone solicitation fund. Specifies that a failure to comply with the "do not call" statute is a deceptive act actionable by the attorney general if the failure to comply is knowing or intentional. Amends the standard of liability under the "do not call" statute for a person who directly or indirectly controls a person who fails to comply with the statute to provide that the controlling person commits a separate deceptive act only if the controlling person knows, or in the exercise of reasonable care should know, of the failure to comply. Amends the definition of "seller" for purposes of the statute requiring telephone solicitors to register with the division, so that the definition includes any person making a telephone solicitation. (Current law includes only persons that making specified false representations in a telephone solicitation.) Provides that all sellers that make telephone solicitations must register with the division. (Under current law, registration is required only if the solicitation involves consideration of more than \$100 and less than \$50,000.) Provides that the attorney general can collect attorney fees and costs in a civil action for a violation of the statute prohibiting misleading or inaccurate caller identification (caller ID statute). Makes technical changes to the deceptive consumer sales act concerning violations of the caller ID statute. Provides that after June 30, 2019, the caller ID statute applies to the transmission of information through a caller ID service only with respect to commercial telephone solicitations. Specifies that for purposes of the caller ID statute, a "commercial telephone solicitation" means an unsolicited call made to a telephone subscriber and with respect to which neither the person initiating the call nor the person's employer or principal has had a prior business or personal relationship with the subscriber.

ENGROSSED HOUSE BILL No. 1123

A BILL FOR AN ACT to amend the Indiana Code concerning trade regulation.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 24-4.7-1-1 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2019]: Sec. 1. This article does not
3 apply to any of the following:
- 4 (1) A telephone call made in response to an express request of the
5 person called.
 - 6 (2) A telephone call made primarily in connection with an
7 existing debt or contract for which payment or performance has
8 not been completed at the time of the call.
 - 9 (3) A telephone call made on behalf of a charitable organization
10 that is exempt from federal income taxation under Section 501 of
11 the Internal Revenue Code, but only if all of the following apply:
 - 12 (A) The telephone call is made by a volunteer or an employee
13 of the charitable organization.
 - 14 (B) The telephone solicitor who makes the telephone call
15 immediately discloses all of the following information upon
16 making contact with the consumer:
 - 17 (i) The solicitor's true first and last name.

- 1 (ii) The name, address, and telephone number of the
 2 charitable organization.
- 3 (4) A telephone call made by an individual licensed under
 4 IC 25-34.1 if:
- 5 (A) the sale of goods or services is not completed; and

 7 until after a face to face sales presentation by the seller.
- 8 (5) A telephone call made by an individual licensed under
 9 IC 27-1-15.6 or IC 27-1-15.8 when the individual is soliciting an

 11 behalf of an insurer (as defined in IC 27-1-2-3), **if:**
- 12 **(A) the individual; or**

 21 **the laws of any state or the United States; or**
 22 **(B) a person licensed by the department of financial**

 24 **that has an established business relationship (as defined in 47**
 25 **CFR 64.1200) with the consumer.**

 12 a person that **knowingly or intentionally** fails to comply with any
 13 provision of IC 24-4.7-4 commits a separate deceptive act that is
 14 actionable by the attorney general under this chapter **if the person who**
 15 **directly or indirectly controls the person that knowingly or**
 16 **intentionally fails to comply knows or, in the exercise of reasonable**

 24 the transaction. An act, omission, or practice prohibited by this section
 25 includes both implicit and explicit misrepresentations.
 26 (b) Without limiting the scope of subsection (a), the following acts,
 27 and the following representations as to the subject matter of a
 28 consumer transaction, made orally, in writing, or by electronic
 29 communication, by a supplier, are deceptive acts:
 30 (1) That such subject of a consumer transaction has sponsorship,
 31 approval, performance, characteristics, accessories, uses, or
 32 benefits it does not have which the supplier knows or should
 33 reasonably know it does not have.
 34 (2) That such subject of a consumer transaction is of a particular
 35 standard, quality, grade, style, or model, if it is not and if the
 36 supplier knows or should reasonably know that it is not.
 37 (3) That such subject of a consumer transaction is new or unused,
 38 if it is not and if the supplier knows or should reasonably know
 39 that it is not.
 40 (4) That such subject of a consumer transaction will be supplied
 41 to the public in greater quantity than the supplier intends or
 42 reasonably expects.



- 1 (5) That replacement or repair constituting the subject of a
2 consumer transaction is needed, if it is not and if the supplier
3 knows or should reasonably know that it is not.
- 4 (6) That a specific price advantage exists as to such subject of a
5 consumer transaction, if it does not and if the supplier knows or
6 should reasonably know that it does not.
- 7 (7) That the supplier has a sponsorship, approval, or affiliation in
8 such consumer transaction the supplier does not have, and which
9 the supplier knows or should reasonably know that the supplier
10 does not have.
- 11 (8) That such consumer transaction involves or does not involve
12 a warranty, a disclaimer of warranties, or other rights, remedies,
13 or obligations, if the representation is false and if the supplier
14 knows or should reasonably know that the representation is false.
- 15 (9) That the consumer will receive a rebate, discount, or other
16 benefit as an inducement for entering into a sale or lease in return
17 for giving the supplier the names of prospective consumers or
18 otherwise helping the supplier to enter into other consumer
19 transactions, if earning the benefit, rebate, or discount is
20 contingent upon the occurrence of an event subsequent to the time
21 the consumer agrees to the purchase or lease.
- 22 (10) That the supplier is able to deliver or complete the subject of
23 the consumer transaction within a stated period of time, when the
24 supplier knows or should reasonably know the supplier could not.
25 If no time period has been stated by the supplier, there is a
26 presumption that the supplier has represented that the supplier
27 will deliver or complete the subject of the consumer transaction
28 within a reasonable time, according to the course of dealing or the
29 usage of the trade.
- 30 (11) That the consumer will be able to purchase the subject of the
31 consumer transaction as advertised by the supplier, if the supplier
32 does not intend to sell it.
- 33 (12) That the replacement or repair constituting the subject of a
34 consumer transaction can be made by the supplier for the estimate
35 the supplier gives a customer for the replacement or repair, if the
36 specified work is completed and:
- 37 (A) the cost exceeds the estimate by an amount equal to or
38 greater than ten percent (10%) of the estimate;
- 39 (B) the supplier did not obtain written permission from the
40 customer to authorize the supplier to complete the work even
41 if the cost would exceed the amounts specified in clause (A);
- 42 (C) the total cost for services and parts for a single transaction



- 1 is more than seven hundred fifty dollars (\$750); and
 2 (D) the supplier knew or reasonably should have known that
 3 the cost would exceed the estimate in the amounts specified in
 4 clause (A).
- 5 (13) That the replacement or repair constituting the subject of a
 6 consumer transaction is needed, and that the supplier disposes of
 7 the part repaired or replaced earlier than seventy-two (72) hours
 8 after both:
 9 (A) the customer has been notified that the work has been
 10 completed; and
 11 (B) the part repaired or replaced has been made available for
 12 examination upon the request of the customer.
- 13 (14) Engaging in the replacement or repair of the subject of a
 14 consumer transaction if the consumer has not authorized the
 15 replacement or repair, and if the supplier knows or should
 16 reasonably know that it is not authorized.
- 17 (15) The act of misrepresenting the geographic location of the
 18 supplier by listing an alternate business name or an assumed
 19 business name (as described in IC 23-0.5-3-4) in a local telephone
 20 directory if:
 21 (A) the name misrepresents the supplier's geographic location;
 22 (B) the listing fails to identify the locality and state of the
 23 supplier's business;
 24 (C) calls to the local telephone number are routinely forwarded
 25 or otherwise transferred to a supplier's business location that
 26 is outside the calling area covered by the local telephone
 27 directory; and
 28 (D) the supplier's business location is located in a county that
 29 is not contiguous to a county in the calling area covered by the
 30 local telephone directory.
- 31 (16) The act of listing an alternate business name or assumed
 32 business name (as described in IC 23-0.5-3-4) in a directory
 33 assistance data base if:
 34 (A) the name misrepresents the supplier's geographic location;
 35 (B) calls to the local telephone number are routinely forwarded
 36 or otherwise transferred to a supplier's business location that
 37 is outside the local calling area; and
 38 (C) the supplier's business location is located in a county that
 39 is not contiguous to a county in the local calling area.
- 40 (17) The violation by a supplier of IC 24-3-4 concerning
 41 cigarettes for import or export.
- 42 (18) The act of a supplier in knowingly selling or reselling a

12 and such other suppliers who shall state orally or in writing that such
13 representation is true if such other supplier shall know or have reason
14 to know that such representation was false.

15 (d) If a supplier shows by a preponderance of the evidence that an
16 act resulted from a bona fide error notwithstanding the maintenance of
17 procedures reasonably adopted to avoid the error, such act shall not be
18 deceptive within the meaning of this chapter.

19 (e) It shall be a defense to any action brought under this chapter that
20 the representation constituting an alleged deceptive act was one made
21 in good faith by the supplier without knowledge of its falsity and in
22 reliance upon the oral or written representations of the manufacturer,
23 the person from whom the supplier acquired the product, any testing
24 organization, or any other person provided that the source thereof is
25 disclosed to the consumer.

26 (f) For purposes of subsection (b)(12), a supplier that provides
27 estimates before performing repair or replacement work for a customer
28 shall give the customer a written estimate itemizing as closely as
29 possible the price for labor and parts necessary for the specific job
30 before commencing the work.

31 (g) For purposes of subsection (b)(15) and (b)(16), a telephone
32 company or other provider of a telephone directory or directory
33 assistance service or its officer or agent is immune from liability for
34 publishing the listing of an alternate business name or assumed
35 business name of a supplier in its directory or directory assistance data
36 base unless the telephone company or other provider of a telephone
37 directory or directory assistance service is the same person as the
38 supplier who has committed the deceptive act.

39 (h) For purposes of subsection (b)(18), it is an affirmative defense
40 to any action brought under this chapter that the product has been
41 altered by a person other than the defendant to render the product
42 completely incapable of serving its original purpose.

Mr. Speaker: Your Committee on Utilities, Energy and Telecommunications, to which was referred House Bill 1123, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill be amended as follows:

Page 1, delete lines 1 through 17, begin a new paragraph and insert:

"SECTION 1. IC 24-4.7-1-1 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2019]: Sec. 1. This article does not apply to any of the following:

- (1) A telephone call made in response to an express request of the person called.
- (2) A telephone call made primarily in connection with an existing debt or contract for which payment or performance has not been completed at the time of the call.
- (3) A telephone call made on behalf of a charitable organization that is exempt from federal income taxation under Section 501 of the Internal Revenue Code, but only if all of the following apply:
 - (A) The telephone call is made by a volunteer or an employee of the charitable organization.
 - (B) The telephone solicitor who makes the telephone call immediately discloses all of the following information upon making contact with the consumer:
 - (i) The solicitor's true first and last name.
 - (ii) The name, address, and telephone number of the charitable organization.
- (4) A telephone call made by an individual licensed under IC 25-34.1 if:
 - (A) the sale of goods or services is not completed; and
 - (B) the payment or authorization of payment is not required; until after a face to face sales presentation by the seller.
- (5) A telephone call made by an individual licensed under IC 27-1-15.6 or IC 27-1-15.8 when the individual is soliciting an application for insurance or negotiating a policy of insurance on behalf of an insurer (as defined in IC 27-1-2-3).
- (6) A telephone call soliciting the sale of a newspaper of general circulation, but only if the telephone call is made by a volunteer or an employee of the newspaper.
- (7) Any telephone call made to a consumer by a communications service provider (as defined in IC 8-1-32.5-4) that has an established business relationship (as defined in 47 CFR 64.1200) with the consumer.**

(5) That replacement or repair constituting the subject of a consumer transaction is needed, if it is not and if the supplier knows or should reasonably know that it is not.

(6) That a specific price advantage exists as to such subject of a consumer transaction, if it does not and if the supplier knows or should reasonably know that it does not.

(7) That the supplier has a sponsorship, approval, or affiliation in such consumer transaction the supplier does not have, and which the supplier knows or should reasonably know that the supplier does not have.

(8) That such consumer transaction involves or does not involve a warranty, a disclaimer of warranties, or other rights, remedies, or obligations, if the representation is false and if the supplier knows or should reasonably know that the representation is false.

(d) If a supplier shows by a preponderance of the evidence that an act resulted from a bona fide error notwithstanding the maintenance of procedures reasonably adopted to avoid the error, such act shall not be deceptive within the meaning of this chapter.

(e) It shall be a defense to any action brought under this chapter that the representation constituting an alleged deceptive act was one made in good faith by the supplier without knowledge of its falsity and in reliance upon the oral or written representations of the manufacturer, the person from whom the supplier acquired the product, any testing organization, or any other person provided that the source thereof is disclosed to the consumer.

(f) For purposes of subsection (b)(12), a supplier that provides estimates before performing repair or replacement work for a customer shall give the customer a written estimate itemizing as closely as possible the price for labor and parts necessary for the specific job before commencing the work.

- (2) one thousand dollars (\$1,000).

Actual damages awarded to a person under this section have priority over any civil penalty imposed under this chapter.

(b) Any person who is entitled to bring an action under subsection (a) on the person's own behalf against a supplier for damages for a deceptive act may bring a class action against such supplier on behalf of any class of persons of which that person is a member and which has been damaged by such deceptive act, subject to and under the Indiana Rules of Trial Procedure governing class actions, except as herein expressly provided. Except as provided in subsection (j), the court may award reasonable attorney fees to the party that prevails in a class action under this subsection, provided that such fee shall be determined by the amount of time reasonably expended by the attorney and not by the amount of the judgment, although the contingency of the fee may be considered. Except in the case of an extension of time granted by the



attorney general under IC 24-10-2-2(b) in an action subject to IC 24-10, any money or other property recovered in a class action under this subsection which cannot, with due diligence, be restored to consumers within one (1) year after the judgment becomes final shall be returned to the party depositing the same. - (1) issue an injunction;

- (3) for a knowing violation against a senior consumer, increase the amount of restitution ordered under subdivision (2) in any amount up to three (3) times the amount of damages incurred or value of property or assets lost;
- (4) order the supplier to pay to the state the reasonable costs of the attorney general's investigation and prosecution related to the action;
- (5) provide for the appointment of a receiver; and

(e) In any action under subsection (a) or (b), upon the filing of the complaint or on the appearance of any defendant, claimant, or any other party, or at any later time, the trial court, the supreme court, or the court of appeals may require the plaintiff, defendant, claimant, or any other party or parties to give security, or additional security, in such



sum as the court shall direct to pay all costs, expenses, and disbursements that shall be awarded against that party or which that party may be directed to pay by any interlocutory order by the final judgment or on appeal.

(f) Any person who violates the terms of an injunction issued under subsection (c) shall forfeit and pay to the state a civil penalty of not more than fifteen thousand dollars (\$15,000) per violation. - (1) not admissible as evidence in a proceeding initiated under this section unless the offer to cure is delivered by a supplier to the consumer or a representative of the consumer before the supplier files the supplier's initial response to a complaint; and
- (2) only admissible as evidence in a proceeding initiated under this section to prove that a supplier is not liable for attorney's fees under subsection (k).

If the offer to cure is timely delivered by the supplier, the supplier may submit the offer to cure as evidence to prove in the proceeding in



accordance with the Indiana Rules of Trial Procedure that the supplier made an offer to cure.

(k) A supplier may not be held liable for the attorney's fees and court costs of the consumer that are incurred following the timely delivery of an offer to cure as described in subsection (j) unless the actual damages awarded, not including attorney's fees and costs, exceed the value of the offer to cure.

(l) If a court finds that a person has knowingly violated section 3(b)(20) of this chapter, the attorney general, in an action under subsection (c), may recover from the person on behalf of the state a civil penalty not exceeding one thousand dollars (\$1,000) per consumer. In determining the amount of the civil penalty in any action by the attorney general under this subsection, the court shall consider, among other relevant factors, the frequency and persistence of noncompliance by the debt collector, the nature of the noncompliance, and the extent to which the noncompliance was intentional. An action by the attorney general for a violation of this chapter may be brought in the circuit or superior court of Marion County.

(b) If the attorney general brings an action under this section and proves by a preponderance of the evidence that a person has knowingly or intentionally violated section 9 of this chapter, the attorney general



may recover from the person on behalf of the state a civil penalty of not more than ten thousand dollars (\$10,000) per violation. A civil penalty recovered under this subsection shall be deposited in the consumer protection division telephone solicitation fund established by IC 24-4.7-3-6 to be used for the administration and enforcement of this chapter.

Page 2, delete lines 26 through 42.

Page 4, delete lines 23 through 42, begin a new paragraph and insert:

"SECTION 4. IC 24-4.7-5-1, AS AMENDED BY P.L.153-2017, SECTION 5, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2019]: Sec. 1. A telephone solicitor, a supplier, or a caller who **knowingly or intentionally** fails to comply with any provision of IC 24-4.7-4 commits a deceptive act that is actionable by the attorney general under this chapter. A person who directly or indirectly controls a person that **knowingly or intentionally** fails to comply with any provision of IC 24-4.7-4 commits a separate deceptive act that is actionable by the attorney general under this chapter **if the person who directly or indirectly controls the person that knowingly or intentionally fails to comply knows or, in the exercise of reasonable care should know, of the failure to comply**. In addition, a contractor who contracts or seeks to contract with the state:

- (1) may be prohibited from contracting with the state; or
- (2) may have an existing contract with the state voided;

if the contractor, an affiliate or principal of the contractor, a person that directly or indirectly controls the contractor, any agent acting on behalf of the contractor or an affiliate or principal of the contractor, or a person that directly or indirectly controls the agent does not comply or has not complied with the terms of this article, even if this article is preempted by federal law.

SECTION 5. IC 24-4.7-5-2, AS AMENDED BY P.L.153-2017, SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2019]: Sec. 2. (a) In an action under this chapter, the attorney general may obtain any or all of the following:
