## ENGROSSED HOUSE BILL No. 1133

---

DIGEST OF HB 1133 (Updated February 26, 2024 2:49 pm - DI 119)

**Citations Affected:** IC 3-9.

**Synopsis:** Use of digitally altered media in elections. Defines "fabricated media" as any of the following: (1) An audio or visual recording of an individual's speech, appearance, or conduct that has been altered without the individual's consent such that: (A) the media conveys a materially inaccurate depiction of the individual's speech, appearance, or conduct as recorded in the unaltered recording; and (B) a reasonable person would be unable to recognize that the recording has been altered. (2) An artificially generated audio or visual imitation

of an individual that: (A) has been created without the individual's consent; (B) is sufficiently lifelike that a reasonable person would be unable to distinguish the speech or appearance of the imitation from the speech or appearance of the individual; and (C) is used to convey a fictional depiction of the individual's speech, appearance, or conduct. (3) Audio or visual media depicting the speech, appearance, or conduct of an artificially generated person, the appearance or speech of which is not a recognizable imitation of an identifiable individual. Requires certain election campaign communications that contain fabricated media to include a disclaimer. Allows a candidate depicted in fabricated media that does not include a required disclaimer to bring a civil action against specified persons.

## ENGROSSED HOUSE BILL No. 1133

A BILL FOR AN ACT to amend the Indiana Code concerning elections.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 3-9-8 IS ADDED TO THE INDIANA CODE AS  
2 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE UPON  
3 PASSAGE]:

4 **Chapter 8. Use of Digitally Altered Media in Elections**

5 **Sec. 1. (a) As used in this chapter, "campaign communication"**  
6 **means a communication, regardless of the format of the**  
7 **communication or the medium through which the communication**  
8 **is disseminated:**

9 (1) that advocates for the election or defeat of a clearly  
10 identified candidate;

11 (2) the purpose of which is to:

12 (A) injure a candidate in an election; or

13 (B) influence the outcome of an election; or

14 (3) that solicits a contribution.

15 (b) For purposes of subsection (a)(1), a candidate is clearly  
16 identified if any of the following apply:

17 (1) The communication includes one (1) or more of the

4 (1) The disclaimer must state: "Elements of this media have  
 5 been digitally altered or artificially generated."

6 (2) If the campaign communication is a printed  
 7 communication, the disclaimer must be printed in a manner  
 8 that complies with IC 3-9-3-2.5(e).

9 (3) If the campaign communication is an audio  
 10 communication, the disclaimer must be read:

11 (A) in each language used in the campaign communication;

12 (B) at a speed and pitch at which the disclaimer is  
 13 reasonably understandable; and

14 (C) at a volume that is not lower than the loudest audio  
 15 included in the campaign communication;

16 at the beginning of the campaign communication, at the end  
 17 of the campaign communication, and, if the campaign  
 18 communication is more than two (2) minutes in length, at  
 19 intervals of two (2) minutes for the duration of the campaign  
 20 communication.

21 (4) If the campaign communication is a video communication,  
 22 the disclaimer must be:

23 (A) printed in a manner that complies with IC 3-9-3-2.5(e);  
 24 and

25 (B) displayed continuously for the duration of the  
 26 campaign communication.

27 Sec. 6. (a) A candidate depicted in fabricated media that is  
 28 included in a campaign communication that does not include a  
 29 disclaimer required by section 5 of this chapter may bring a civil  
 30 action against:

31 (1) the person that paid for the campaign communication;

32 (2) the person that sponsored the campaign communication;  
 33 and

34 (3) a person that disseminates the campaign communication,  
 35 if:

36 (A) the campaign communication included the disclaimer  
 37 when provided to the person; and

38 (B) the person knowingly, intentionally, or recklessly  
 39 altered or removed the disclaimer before disseminating the  
 40 campaign communication.

41 (b) A plaintiff who prevails in an action brought under  
 42 subsection (a) is entitled to recover:



1           **(1) the plaintiff's actual damages;**  
2           **(2) injunctive relief; and**  
3           **(3) the amount of any court costs and reasonable attorney's**  
4           **fees incurred by the plaintiff in connection with the action.**  
5           **(c) The plaintiff in an action under this section has the burden**  
6           **of proving by clear and convincing evidence that the plaintiff was**  
7           **depicted in fabricated media in the campaign communication that**  
8           **is the subject of the action.**  
9           **(d) A court shall expedite the hearing of an action brought**  
10          **under this section.**  
11          **SECTION 2. An emergency is declared for this act.**

Madam President: The Senate Committee on Elections, to which was referred House Bill No. 1133, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Page 1, delete lines 1 through 4, begin a new paragraph and insert:

"SECTION 1. IC 3-9-8 IS ADDED TO THE INDIANA CODE AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]:

**Chapter 8. Use of Digitally Altered Media in Elections**

**Sec. 1. (a) As used in this chapter, "campaign communication" means a communication, regardless of the format of the communication or the medium through which the communication is disseminated, that:**

- (1) advocates for the election or defeat of a clearly identified candidate; or**
- (2) solicits a contribution.**

**(b) For purposes of this section, a candidate is clearly identified if any of the following apply:**

- (1) The communication includes one (1) or more of the following:**
  - (A) The name of the candidate.**
  - (B) A video, photograph, or drawing of the candidate.**
  - (C) Fabricated media depicting the candidate.**
- (2) The identity of the candidate is apparent by unambiguous reference.**

**Sec. 2. (a) For purposes of this chapter, subject to subsection (b), "candidate" has the meaning set forth in IC 3-5-2-6.**

**(b) For purposes of this chapter, "candidate" includes an individual who holds an elected office, including:**

- (1) a federal or state office, including a federal or state legislative office;**
- (2) a school board office; or**
- (3) a local office.**

**Sec. 3. As used in this chapter, "fabricated media" means any of the following:"**

**"(3) Media depicting the speech, appearance, or conduct of an artificially generated person, the appearance or speech of which is not a recognizable imitation of an identifiable individual."**
