ENGROSSED HOUSE BILL No. 1137

DIGEST OF HB 1137 (Updated April 5, 2017 4:49 pm - DI 106)

Citations Affected: IC 27-10; IC 34-45; IC 35-31.5; IC 35-33.

Synopsis: Bail agent license renewal and bond forfeiture. Decreases the bail agent renewal fee from \$600 to \$300. Requires forfeiture, not earlier than 120 days or later than 365 days after the defendant's failure to appear, of a bond executed through cash or securities deposited with the clerk of court. (Current law requires forfeiture not earlier than 120 days after failure to appear.) Provides that the supreme court should adopt rules to establish the Indiana pretrial risk assessment system before January 1, 2020, to assist courts in assessing an arrestee's likelihood of: (1) committing a new criminal offense; or (2) failing to appear. Repeals a provision relating to the impeachment of witnesses.

Effective: July 1, 2017.

ENGROSSED HOUSE BILL No. 1137

A BILL FOR AN ACT to amend the Indiana Code concerning insurance.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 27-10-3-7, AS AMENDED BY P.L.81-2012,
2 SECTION 39, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2017]: Sec. 7. (a) A renewal license shall be issued by the
4 commissioner to a licensee who:
5 (1) has continuously maintained a license in effect;
6 (2) pays a renewal fee of:
7 (A) ~~six hundred dollars (\$600)~~ **three hundred dollars (\$300)**
8 for bail agents; and
9 (B) three hundred dollars (\$300) for recovery agents;
10 (3) has fulfilled the continuing education requirement as required
11 under subsection (b);
12 (4) satisfactorily completes a renewal examination if required by
13 the commissioner; and
14 (5) has in all other respects complied with and been subject to this
15 article.
16 (b) A licensee shall complete at least six (6) hours of continuing
17 education courses that:

- 1 (1) are approved under section 7.1 of this chapter; and
 2 (2) apply to the licensee's particular license, including instruction
 3 in the laws that relate to the conduct of a bail agent or recovery
 4 agent;

5 during each license period. A continuing education course that is used
 6 to fulfill the continuing education requirements for an insurance
 7 producer license under IC 27-1-15.7 may not be used to satisfy the
 8 continuing education requirement set forth in this section.

9 (c) After the receipt of the licensee's application for renewal, the
 10 current license continues in effect until the renewal license is issued,
 11 suspended, or denied for cause.

12 SECTION 2. IC 34-45-4 IS REPEALED [EFFECTIVE JULY 1,
 13 2017]. (Impeachment of Witnesses).

14 SECTION 3. IC 35-31.5-2-121.5 IS ADDED TO THE INDIANA
 15 CODE AS A NEW SECTION TO READ AS FOLLOWS
 16 [EFFECTIVE JULY 1, 2017]: **Sec. 121.5. "Evidence based risk
 17 assessment", for purposes of IC 35-33-8, has the meaning set forth
 18 in IC 35-33-8-0.5.**

19 SECTION 4. IC 35-31.5-2-168.9 IS ADDED TO THE INDIANA
 20 CODE AS A NEW SECTION TO READ AS FOLLOWS
 21 [EFFECTIVE JULY 1, 2017]: **Sec. 168.9. "Indiana pretrial risk
 22 assessment system", for purposes of IC 35-33-8, has the meaning
 23 set forth in IC 35-33-8-0.5.**

24 SECTION 5. IC 35-33-8-0.5 IS ADDED TO THE INDIANA CODE
 25 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
 26 1, 2017]: **Sec. 0.5. (a) The following definitions apply throughout
 27 this chapter:**

- 28 (1) "Evidence based risk assessment" means an assessment:
 29 (A) that identifies factors relevant to determine whether an
 30 arrestee is likely to:
 31 (i) commit a new criminal offense; or
 32 (ii) fail to appear;
 33 if released on bail or pretrial supervision; and
 34 (B) that is based on empirical data derived through
 35 validated criminal justice scientific research.
 36 (2) "Indiana pretrial risk assessment system" means the
 37 statewide evidence based risk assessment system described in
 38 subsection (b).

39 (b) Before January 1, 2020, the supreme court should adopt
 40 rules to establish a statewide evidence based risk assessment
 41 system to assist courts in selecting the appropriate level of bail or
 42 other pretrial supervision for arrestees eligible for pretrial release.



1 **The system must consist of:**

- 2 **(1) an evidence based risk assessment tool; and**
 3 **(2) other rules as adopted by the supreme court.**

4 **(c) The Indiana pretrial risk assessment system shall be**
 5 **designed to assist the courts in assessing an arrestee's likelihood of:**

- 6 **(1) committing a new criminal offense; or**
 7 **(2) failing to appear.**

8 SECTION 6. IC 35-33-8-3.2, AS AMENDED BY P.L.35-2012,
 9 SECTION 107, IS AMENDED TO READ AS FOLLOWS
 10 [EFFECTIVE JULY 1, 2017]: Sec. 3.2. (a) **After considering the**
 11 **results of the Indiana pretrial risk assessment system (if available),**
 12 **other relevant factors, and bail guidelines described in section 3.8**
 13 **of this chapter,** a court may admit a defendant to bail and impose any
 14 of the following conditions to assure the defendant's appearance at any
 15 stage of the legal proceedings, or, upon a showing of clear and
 16 convincing evidence that the defendant poses a risk of physical danger
 17 to another person or the community, to assure the public's physical
 18 safety:

- 19 (1) Require the defendant to:
 20 (A) execute a bail bond with sufficient solvent sureties;
 21 (B) deposit cash or securities in an amount equal to the bail;
 22 (C) execute a bond secured by real estate in the county, where
 23 thirty-three hundredths (0.33) of the true tax value less
 24 encumbrances is at least equal to the amount of the bail;
 25 (D) post a real estate bond; or
 26 (E) perform any combination of the requirements described in
 27 clauses (A) through (D).

28 If the court requires the defendant to deposit cash or cash and
 29 another form of security as bail, the court may require the
 30 defendant and each person who makes the deposit on behalf of the
 31 defendant to execute an agreement that allows the court to retain
 32 all or a part of the cash to pay publicly paid costs of
 33 representation and fines, costs, fees, and restitution that the court
 34 may order the defendant to pay if the defendant is convicted. The
 35 defendant must also pay the fee required by subsection (d).

- 36 (2) Require the defendant to execute:
 37 (A) a bail bond by depositing cash or securities with the clerk
 38 of the court in an amount not less than ten percent (10%) of
 39 the bail; and
 40 (B) an agreement that allows the court to retain all or a part of
 41 the cash or securities to pay fines, costs, fees, and restitution
 42 that the court may order the defendant to pay if the defendant



- 1 is convicted.
- 2 A portion of the deposit, not to exceed ten percent (10%) of the
3 monetary value of the deposit or fifty dollars (\$50), whichever is
4 the lesser amount, may be retained as an administrative fee. The
5 clerk shall also retain from the deposit under this subdivision
6 fines, costs, fees, and restitution as ordered by the court, publicly
7 paid costs of representation that shall be disposed of in
8 accordance with subsection (b), and the fee required by
9 subsection (d). In the event of the posting of a real estate bond,
10 the bond shall be used only to insure the presence of the
11 defendant at any stage of the legal proceedings, but shall not be
12 foreclosed for the payment of fines, costs, fees, or restitution. The
13 individual posting bail for the defendant or the defendant
14 admitted to bail under this subdivision must be notified by the
15 sheriff, court, or clerk that the defendant's deposit may be
16 forfeited under section 7 of this chapter or retained under
17 subsection (b).
- 18 (3) Impose reasonable restrictions on the activities, movements,
19 associations, and residence of the defendant during the period of
20 release.
- 21 (4) Except as provided in section 3.6 of this chapter, require the
22 defendant to refrain from any direct or indirect contact with an
23 individual and, if the defendant has been charged with an offense
24 under IC 35-46-3, any animal belonging to the individual,
25 including if the defendant has not been released from lawful
26 detention.
- 27 (5) Place the defendant under the reasonable supervision of a
28 probation officer, pretrial services agency, or other appropriate
29 public official. If the court places the defendant under the
30 supervision of a probation officer or pretrial services agency, the
31 court shall determine whether the defendant must pay the pretrial
32 services fee under section 3.3 of this chapter.
- 33 (6) Release the defendant into the care of a qualified person or
34 organization responsible for supervising the defendant and
35 assisting the defendant in appearing in court. The supervisor shall
36 maintain reasonable contact with the defendant in order to assist
37 the defendant in making arrangements to appear in court and,
38 where appropriate, shall accompany the defendant to court. The
39 supervisor need not be financially responsible for the defendant.
- 40 (7) Release the defendant on personal recognizance unless:
- 41 (A) the state presents evidence relevant to a risk by the
42 defendant:



- 1 (i) of nonappearance; or
 2 (ii) to the physical safety of the public; and
 3 (B) the court finds by a preponderance of the evidence that the
 4 risk exists.
 5 (8) Require a defendant charged with an offense under IC 35-46-3
 6 to refrain from owning, harboring, or training an animal.
 7 (9) Impose any other reasonable restrictions designed to assure
 8 the defendant's presence in court or the physical safety of another
 9 person or the community.
 10 (b) Within thirty (30) days after disposition of the charges against
 11 the defendant, the court that admitted the defendant to bail shall order
 12 the clerk to remit the amount of the deposit remaining under subsection
 13 (a)(2) to the defendant. The portion of the deposit that is not remitted
 14 to the defendant shall be deposited by the clerk in the supplemental
 15 public defender services fund established under IC 33-40-3.
 16 (c) For purposes of subsection (b), "disposition" occurs when the
 17 indictment or information is dismissed or the defendant is acquitted or
 18 convicted of the charges.
 19 (d) Except as provided in subsection (e), the clerk of the court shall:
 20 (1) collect a fee of five dollars (\$5) from each bond or deposit
 21 required under subsection (a)(1); and
 22 (2) retain a fee of five dollars (\$5) from each deposit under
 23 subsection (a)(2).
 24 The clerk of the court shall semiannually remit the fees collected under
 25 this subsection to the board of trustees of the Indiana public retirement
 26 system for deposit in the special death benefit fund. The fee required
 27 by subdivision (2) is in addition to the administrative fee retained under
 28 subsection (a)(2).
 29 (e) With the approval of the clerk of the court, the county sheriff
 30 may collect the bail posted under this section. The county sheriff shall
 31 remit the bail to the clerk of the court by the following business day
 32 and remit monthly the five dollar (\$5) special death benefit fee to the
 33 county auditor.
 34 (f) When a court imposes a condition of bail described in subsection
 35 (a)(4):
 36 (1) the clerk of the court shall comply with IC 5-2-9; and
 37 (2) the prosecuting attorney shall file a confidential form
 38 prescribed or approved by the division of state court
 39 administration with the clerk.
 40 SECTION 7. IC 35-33-8-3.5, AS ADDED BY P.L.74-2008,
 41 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 42 JULY 1, 2017]: Sec. 3.5. (a) This section applies only to a sexually

- 23 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY**
- 24 **1, 2017]: Sec. 3.8. (a) A court shall consider the results of the**
- 25 **Indiana pretrial risk assessment system (if available) before setting**
- 26 **or modifying bail for an arrestee.**
- 27 (b) **If the court finds, based on the results of the Indiana pretrial**
- 28 **risk assessment system (if available) and other relevant factors,**
- 29 **that an arrestee does not present a substantial risk of flight or**
- 30 **danger to the arrestee or others, the court shall consider releasing**
- 31 **the arrestee without money bail or surety, subject to restrictions**
- 32 **and conditions as determined by the court, unless one (1) or more**
- 33 **of the following apply:**
- 34 (1) **The arrestee is charged with murder or treason.**
- 35 (2) **The arrestee is on pretrial release not related to the**
- 36 **incident that is the basis for the present arrest.**

- 39 **The court is not required to administer an assessment before**
- 40 **releasing an arrestee if administering the assessment will delay the**

1 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
2 1, 2017]: **Sec. 3.9. (a) If the court determines that an arrestee is to
3 be held subject to money bail, the court is authorized to determine
4 the amount of bail and whether the bail may be satisfied by surety
5 bond or cash deposit.**

6 **(b) The court may set and accept a partial cash payment of the
7 bail upon conditions set by the court, including the arrestee's
8 agreement (and the agreement of a person who makes a cash
9 payment on behalf of an arrestee, if applicable) that all court costs,
10 fees, and expenses associated with the proceeding shall be paid
11 from the partial payment.**

12 **(c) If the court authorizes the acceptance of a cash partial
13 payment to satisfy bail, the court shall first secure the arrestee's
14 agreement (and the agreement of a person who makes a cash
15 payment on behalf of an arrestee, if applicable) that, in the event
16 of failure to appear as scheduled, the deposit shall be forfeited and
17 the arrestee must also pay any additional amounts needed to satisfy
18 the full amount of bail plus associated court costs, fees, and
19 expenses.**

20 SECTION 10. IC 35-33-8-4, AS AMENDED BY P.L.171-2011,
21 SECTION 21, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
22 JULY 1, 2017]: **Sec. 4. (a) The court shall order the amount in which
23 a person charged by an indictment or information is to be held to bail,
24 and the clerk shall enter the order on the order book and indorse the
25 amount on each warrant when issued. If no order fixing the amount of
26 bail has been made, the sheriff shall present the warrant to the judge of
27 an appropriate court of criminal jurisdiction, and the judge shall
28 indorse on the warrant the amount of bail.**

29 **(b) Bail may not be set higher than that amount reasonably required
30 to assure the defendant's appearance in court or to assure the physical
31 safety of another person or the community if the court finds by clear
32 and convincing evidence that the defendant poses a risk to the physical
33 safety of another person or the community. In setting and accepting an
34 amount of bail, the judicial officer shall **consider the bail guidelines
35 described in section 3.8 of this chapter and** take into account all facts
36 relevant to the risk of nonappearance, including:**

- 37 (1) the length and character of the defendant's residence in the
38 community;
- 39 (2) the defendant's employment status and history and **his the
40 defendant's** ability to give bail;
- 41 (3) the defendant's family ties and relationships;
- 42 (4) the defendant's character, reputation, habits, and mental



- 1 condition;
- 2 (5) the defendant's criminal or juvenile record, insofar as it
- 3 demonstrates instability and a disdain for the court's authority to
- 4 bring **him the defendant** to trial;
- 5 (6) the defendant's previous record in not responding to court
- 6 appearances when required or with respect to flight to avoid
- 7 criminal prosecution;
- 8 (7) the nature and gravity of the offense and the potential penalty
- 9 faced, insofar as these factors are relevant to the risk of
- 10 nonappearance;
- 11 (8) the source of funds or property to be used to post bail or to pay
- 12 a premium, insofar as it affects the risk of nonappearance;
- 13 (9) that the defendant is a foreign national who is unlawfully
- 14 present in the United States under federal immigration law; and
- 15 (10) any other factors, including any evidence of instability and
- 16 a disdain for authority, which might indicate that the defendant
- 17 might not recognize and adhere to the authority of the court to
- 18 bring **him the defendant** to trial.

19 SECTION 11. IC 35-33-8-4.5, AS ADDED BY P.L.171-2011,

20 SECTION 22, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE

21 JULY 1, 2017]: Sec. 4.5. (a) If bail is set for a defendant who is a

23 federal immigration law, ~~the defendant may be released from custody~~

24 ~~only by posting a:~~ **after considering the results of the Indiana**

 7 the court shall, except as provided in subsection (b) or section 8(b) of
 8 this chapter, declare the bond forfeited not earlier than one hundred
 9 twenty (120) **days or more than three hundred sixty-five (365)** days
 10 after the defendant's failure to appear and issue a warrant for the
 11 defendant's arrest.

12 (b) In a criminal case, if the court having jurisdiction over the
 13 criminal case receives written notice of a pending civil action or

 23 order the remainder of the deposit, if any, and the bond forfeited.

24 (c) Any proceedings concerning the bond, or its forfeiture,
 25 judgment, or execution of judgment, shall be held in the court that
 26 admitted the defendant to bail.

27 (d) After a bond has been forfeited under subsection (a) or (b), the
 28 clerk shall mail notice of forfeiture to the defendant. In addition, unless
 29 the court finds that there was justification for the defendant's failure to
 30 appear, the court shall immediately enter judgment, without pleadings
 31 and without change of judge or change of venue, against the defendant
 32 for the amount of the bail bond, and the clerk shall record the
 33 judgment.

34 (e) If a bond is forfeited and the court has entered a judgment under
 35 subsection (d), the clerk shall transfer to the state common school fund:

36 (1) any amount remaining on deposit with the court (less the fees
 37 retained by the clerk); and

38 (2) any amount collected in satisfaction of the judgment.

39 (f) The clerk shall return a deposit, less the administrative fee, made
 40 under section 3.2(a)(2) of this chapter to the defendant, if the defendant

Madam President: The Senate Committee on Insurance and Financial Institutions, to which was referred House Bill No. 1137, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Page 2, after line 11, begin a new paragraph and insert:

"SECTION 2. IC 35-33-8-7, AS AMENDED BY P.L.105-2010, SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2017]: Sec. 7. (a) If a defendant:

(1) was admitted to bail under section 3.2(a)(2) of this chapter; and

(2) has failed to appear before the court as ordered;

the court shall, except as provided in subsection (b) or section 8(b) of this chapter, declare the bond forfeited not ~~earlier~~ **later** than ~~one~~ **three** hundred ~~twenty~~ ~~(120)~~ **sixty-five (365)** days after the defendant's failure to appear and issue a warrant for the defendant's arrest.

(b) In a criminal case, if the court having jurisdiction over the criminal case receives written notice of a pending civil action or unsatisfied judgment against the criminal defendant arising out of the same transaction or occurrence forming the basis of the criminal case, funds deposited with the clerk of the court under section 3.2(a)(2) of this chapter may not be declared forfeited by the court, and the court shall order the deposited funds to be held by the clerk. if the deposit and the bond are subject to forfeiture, the criminal court shall order payment of all or any part of the deposit to the plaintiff in the action, as is necessary to satisfy the judgment. The court shall then order the remainder of the deposit, if any, and the bond forfeited.

(c) Any proceedings concerning the bond, or its forfeiture, judgment, or execution of judgment, shall be held in the court that admitted the defendant to bail.

(d) After a bond has been forfeited under subsection (a) or (b), the clerk shall mail notice of forfeiture to the defendant. In addition, unless the court finds that there was justification for the defendant's failure to appear, the court shall immediately enter judgment, without pleadings and without change of judge or change of venue, against the defendant for the amount of the bail bond, and the clerk shall record the judgment.

(e) If a bond is forfeited and the court has entered a judgment under subsection (d), the clerk shall transfer to the state common school fund:

- (1) any amount remaining on deposit with the court (less the fees retained by the clerk); and
- (2) any amount collected in satisfaction of the judgment.

(f) The clerk shall return a deposit, less the administrative fee, made under section 3.2(a)(2) of this chapter to the defendant, if the defendant appeared at trial and the other critical stages of the legal proceedings."

SECTION 4. IC 35-31.5-2-168.9 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2017]: **Sec. 168.9. "Indiana pretrial risk assessment system", for purposes of IC 35-33-8, has the meaning set forth in IC 35-33-8-0.5.**

SECTION 5. IC 35-33-8-0.5 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2017]: **Sec. 0.5. (a) The following definitions apply throughout this chapter:**

- (1) "Evidence based risk assessment" means an assessment:**
 - (A) that identifies factors relevant to determine whether an arrestee is likely to:**
 - (i) commit a new criminal offense; or**
 - (ii) fail to appear;**
 - if released on bail or pretrial supervision; and**
 - (B) that is based on empirical data derived through validated criminal justice scientific research.**
- (2) "Indiana pretrial risk assessment system" means the statewide evidence based risk assessment system described in subsection (b).**

(b) Before January 1, 2020, the supreme court should adopt rules to establish a statewide evidence based risk assessment system to assist courts in selecting the appropriate level of bail or other pretrial supervision for arrestees eligible for pretrial release. The system must consist of:

- (1) an evidence based risk assessment tool; and**
- (2) other rules as adopted by the supreme court.**

(c) The Indiana pretrial risk assessment system shall be designed to assist the courts in assessing an arrestee's likelihood of:

- (1) committing a new criminal offense; or**
- (2) failing to appear.**

SECTION 6. IC 35-33-8-3.2, AS AMENDED BY P.L.35-2012, SECTION 107, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2017]: **Sec. 3.2. (a) After considering the results of the Indiana pretrial risk assessment system (if available), other relevant factors, and bail guidelines described in section 3.8 of this chapter, a court may admit a defendant to bail and impose any of the following conditions to assure the defendant's appearance at any stage of the legal proceedings, or, upon a showing of clear and convincing evidence that the defendant poses a risk of physical danger to another person or the community, to assure the public's physical**



safety:

- (1) Require the defendant to:
 - (A) execute a bail bond with sufficient solvent sureties;
 - (B) deposit cash or securities in an amount equal to the bail;
 - (C) execute a bond secured by real estate in the county, where thirty-three hundredths (0.33) of the true tax value less encumbrances is at least equal to the amount of the bail;
 - (D) post a real estate bond; or
 - (E) perform any combination of the requirements described in clauses (A) through (D).

If the court requires the defendant to deposit cash or cash and another form of security as bail, the court may require the defendant and each person who makes the deposit on behalf of the defendant to execute an agreement that allows the court to retain all or a part of the cash to pay publicly paid costs of representation and fines, costs, fees, and restitution that the court may order the defendant to pay if the defendant is convicted. The defendant must also pay the fee required by subsection (d).

- (2) Require the defendant to execute:
 - (A) a bail bond by depositing cash or securities with the clerk of the court in an amount not less than ten percent (10%) of the bail; and
 - (B) an agreement that allows the court to retain all or a part of the cash or securities to pay fines, costs, fees, and restitution that the court may order the defendant to pay if the defendant is convicted.

A portion of the deposit, not to exceed ten percent (10%) of the monetary value of the deposit or fifty dollars (\$50), whichever is the lesser amount, may be retained as an administrative fee. The clerk shall also retain from the deposit under this subdivision fines, costs, fees, and restitution as ordered by the court, publicly paid costs of representation that shall be disposed of in accordance with subsection (b), and the fee required by subsection (d). In the event of the posting of a real estate bond, the bond shall be used only to insure the presence of the defendant at any stage of the legal proceedings, but shall not be foreclosed for the payment of fines, costs, fees, or restitution. The individual posting bail for the defendant or the defendant admitted to bail under this subdivision must be notified by the sheriff, court, or clerk that the defendant's deposit may be forfeited under section 7 of this chapter or retained under subsection (b).



(3) Impose reasonable restrictions on the activities, movements, associations, and residence of the defendant during the period of release.

(4) Except as provided in section 3.6 of this chapter, require the defendant to refrain from any direct or indirect contact with an individual and, if the defendant has been charged with an offense under IC 35-46-3, any animal belonging to the individual, including if the defendant has not been released from lawful detention.

(5) Place the defendant under the reasonable supervision of a probation officer, pretrial services agency, or other appropriate public official. If the court places the defendant under the supervision of a probation officer or pretrial services agency, the court shall determine whether the defendant must pay the pretrial services fee under section 3.3 of this chapter.

(6) Release the defendant into the care of a qualified person or organization responsible for supervising the defendant and assisting the defendant in appearing in court. The supervisor shall maintain reasonable contact with the defendant in order to assist the defendant in making arrangements to appear in court and, where appropriate, shall accompany the defendant to court. The supervisor need not be financially responsible for the defendant.

(7) Release the defendant on personal recognizance unless:

(A) the state presents evidence relevant to a risk by the defendant:

(i) of nonappearance; or

(ii) to the physical safety of the public; and

(B) the court finds by a preponderance of the evidence that the risk exists.

(8) Require a defendant charged with an offense under IC 35-46-3 to refrain from owning, harboring, or training an animal.

(9) Impose any other reasonable restrictions designed to assure the defendant's presence in court or the physical safety of another person or the community.

(b) Within thirty (30) days after disposition of the charges against the defendant, the court that admitted the defendant to bail shall order the clerk to remit the amount of the deposit remaining under subsection (a)(2) to the defendant. The portion of the deposit that is not remitted to the defendant shall be deposited by the clerk in the supplemental public defender services fund established under IC 33-40-3.

(c) For purposes of subsection (b), "disposition" occurs when the indictment or information is dismissed or the defendant is acquitted or



convicted of the charges.

(d) Except as provided in subsection (e), the clerk of the court shall:

- (1) collect a fee of five dollars (\$5) from each bond or deposit required under subsection (a)(1); and
- (2) retain a fee of five dollars (\$5) from each deposit under subsection (a)(2).

The clerk of the court shall semiannually remit the fees collected under this subsection to the board of trustees of the Indiana public retirement system for deposit in the special death benefit fund. The fee required by subdivision (2) is in addition to the administrative fee retained under subsection (a)(2).

(e) With the approval of the clerk of the court, the county sheriff may collect the bail posted under this section. The county sheriff shall remit the bail to the clerk of the court by the following business day and remit monthly the five dollar (\$5) special death benefit fee to the county auditor.

(f) When a court imposes a condition of bail described in subsection (a)(4):

- (1) the clerk of the court shall comply with IC 5-2-9; and
- (2) the prosecuting attorney shall file a confidential form prescribed or approved by the division of state court administration with the clerk.

SECTION 7. IC 35-33-8-3.5, AS ADDED BY P.L.74-2008, SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2017]: Sec. 3.5. (a) This section applies only to a sexually violent predator defendant.

(b) As used in this section, "sexually violent predator defendant" means a person who:

- (1) is a sexually violent predator under IC 35-38-1-7.5; and
- (2) is arrested for or charged with the commission of an offense that would classify the person as a sex or violent offender (as defined in IC 11-8-8-5).

(c) A court may not admit a:

- (1) sexually violent predator defendant;
- (2) person charged with child molesting (IC 35-42-4-3); or
- (3) person charged with child solicitation (IC 35-42-4-6);

to bail until the court has conducted a bail hearing in open court. Except as provided in section 6 of this chapter, the court shall conduct a bail hearing not later than forty-eight (48) hours after the person has been arrested, unless exigent circumstances prevent holding the hearing within forty-eight (48) hours.

(d) At the conclusion of the hearing described in subsection (c) **and**



after consideration of the bail guidelines described in section 3.8 of this chapter, the court shall consider whether the factors described in ~~IC 35-33-8-4~~ section 4 of this chapter warrant the imposition of a bail amount that exceeds court or county guidelines, if applicable.

SECTION 8. IC 35-33-8-3.8 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2017]: **Sec. 3.8. (a) A court shall consider the results of the Indiana pretrial risk assessment system (if available) before setting or modifying bail for an arrestee.**

(b) If the court finds, based on the results of the Indiana pretrial risk assessment system (if available) and other relevant factors, that an arrestee does not present a substantial risk of flight or danger to the arrestee or others, the court shall consider releasing the arrestee without money bail or surety, subject to restrictions and conditions as determined by the court, unless one (1) or more of the following apply:

- (1) The arrestee is charged with murder or treason.**
- (2) The arrestee is on pretrial release not related to the incident that is the basis for the present arrest.**
- (3) The arrestee is on probation, parole, or other community supervision.**

The court is not required to administer an assessment before releasing an arrestee if administering the assessment will delay the arrestee's release.

SECTION 9. IC 35-33-8-3.9 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2017]: **Sec. 3.9. (a) If the court determines that an arrestee is to be held subject to money bail, the court is authorized to determine the amount of bail and whether the bail may be satisfied by surety bond or cash deposit.**

(b) The court may set and accept a partial cash payment of the bail upon conditions set by the court, including the arrestee's agreement (and the agreement of a person who makes a cash payment on behalf of an arrestee, if applicable) that all court costs, fees, and expenses associated with the proceeding shall be paid from the partial payment.

(c) If the court authorizes the acceptance of a cash partial payment to satisfy bail, the court shall first secure the arrestee's agreement (and the agreement of a person who makes a cash payment on behalf of an arrestee, if applicable) that, in the event of failure to appear as scheduled, the deposit shall be forfeited and the arrestee must also pay any additional amounts needed to satisfy



the full amount of bail plus associated court costs, fees, and expenses.

SECTION 10. IC 35-33-8-4, AS AMENDED BY P.L.171-2011, SECTION 21, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2017]: Sec. 4. (a) The court shall order the amount in which a person charged by an indictment or information is to be held to bail, and the clerk shall enter the order on the order book and indorse the amount on each warrant when issued. If no order fixing the amount of bail has been made, the sheriff shall present the warrant to the judge of an appropriate court of criminal jurisdiction, and the judge shall indorse on the warrant the amount of bail.

(b) Bail may not be set higher than that amount reasonably required to assure the defendant's appearance in court or to assure the physical safety of another person or the community if the court finds by clear and convincing evidence that the defendant poses a risk to the physical safety of another person or the community. In setting and accepting an amount of bail, the judicial officer shall **consider the bail guidelines described in section 3.8 of this chapter** and take into account all facts relevant to the risk of nonappearance, including:

- (1) the length and character of the defendant's residence in the community;
- (2) the defendant's employment status and history and **his the defendant's** ability to give bail;
- (3) the defendant's family ties and relationships;
- (4) the defendant's character, reputation, habits, and mental condition;
- (5) the defendant's criminal or juvenile record, insofar as it demonstrates instability and a disdain for the court's authority to bring **him the defendant** to trial;
- (6) the defendant's previous record in not responding to court appearances when required or with respect to flight to avoid criminal prosecution;
- (7) the nature and gravity of the offense and the potential penalty faced, insofar as these factors are relevant to the risk of nonappearance;
- (8) the source of funds or property to be used to post bail or to pay a premium, insofar as it affects the risk of nonappearance;
- (9) that the defendant is a foreign national who is unlawfully present in the United States under federal immigration law; and
- (10) any other factors, including any evidence of instability and a disdain for authority, which might indicate that the defendant might not recognize and adhere to the authority of the court to



bring ~~him~~ **the defendant** to trial.

SECTION 11. IC 35-33-8-4.5, AS ADDED BY P.L.171-2011, SECTION 22, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2017]: Sec. 4.5. (a) If bail is set for a defendant who is a foreign national who is unlawfully present in the United States under federal immigration law, ~~the defendant may be released from custody only by posting a:~~ **after considering the results of the Indiana pretrial risk assessment system (if available) and other relevant factors, and the bail guidelines described in section 3.8 of this chapter, the court shall consider requiring as bail a:**

- (1) cash bond in an amount equal to the bail;
- (2) real estate bond in which the net equity in the real estate is at least two (2) times the amount of the bail; or
- (3) surety bond in the full amount of the bail that is written by a licensed and appointed agent of an insurer (as defined in IC 27-10-1-7).

(b) If the defendant for whom bail has been posted under this section does not appear before the court as ordered because the defendant has been:

- (1) taken into custody or deported by a federal agency; or
- (2) arrested and incarcerated for another offense;

the bond posted under this section may not be declared forfeited by the court and the insurer (as defined in IC 27-10-1-7) that issued the bond is released from any liability regarding the defendant's failure to appear."
