DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-41-21.2.

Synopsis: Preschool and child care facility drinking water. Requires the individual or entity having authority over a child care facility or preschool to test the drinking water in the child care facility or preschool before January 1, 2025, to determine whether lead is present in the drinking water. Identifies exceptions to testing before January 1, 2025. Requires action to reduce lead concentration that equals or exceeds the action level for lead.

Effective: July 1, 2023.

- (b) Drinking water testing required by this section must be performed in accordance with the lead sampling program for school buildings and child care facilities conducted by the Indiana finance authority.
- (c) If the drinking water in a child care facility or preschool was tested through the lead sampling program for school buildings and child care facilities conducted by the Indiana finance authority in 2019 and 2020, the drinking water of the child care facility or preschool is not required to be tested before January 1, 2025, as described in subsection (a).
- (d) If any testing of drinking water in a child care facility or preschool under subsection (a) or (c) indicates that the presence of lead in the drinking water equals or exceeds the action level for lead, the individual or entity having authority over the child care facility or preschool shall take action to reduce the concentration of lead in the drinking water to below the action level for lead.
