

HOUSE BILL No. 1143

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-43.

Synopsis: Small school grants. Reestablishes a small school grant for school corporations having a current ADM (average daily membership) of less than 2,400. Appropriates from the state general fund an amount sufficient to make the grants for the 2017-2019 biennium.

Effective: July 1, 2017.

HOUSE BILL No. 1143

A BILL FOR AN ACT to amend the Indiana Code concerning education and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-43-2-3, AS AMENDED BY P.L.213-2015,
2 SECTION 208, IS AMENDED TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2017]: Sec. 3. If the total amount to be
4 distributed:
5 (1) as basic tuition support;
6 (2) for honors diploma awards;
7 (3) for complexity grants;
8 (4) for special education grants;
9 (5) for career and technical education grants;
10 (6) for choice scholarships; ~~and~~
11 (7) for Mitch Daniels early graduation scholarships; **and**
12 **(8) for small school grants;**
13 for a particular state fiscal year exceeds the amounts appropriated by
14 the general assembly for those purposes for the state fiscal year, the
15 total amount to be distributed for those purposes to each recipient
16 during the remaining months of the state fiscal year shall be
17 proportionately reduced so that the total reductions equal the amount



1 of the excess.

2 SECTION 2. IC 20-43-16 IS ADDED TO THE INDIANA CODE
3 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
4 JULY 1, 2017]:

5 **Chapter 16. Small School Grants**

6 **Sec. 1. This chapter does not apply to a charter school.**

7 **Sec. 2. This chapter applies to a state fiscal year beginning after**
8 **June 30, 2017.**

9 **Sec. 3. As used in this chapter, "eligible school corporation"**
10 **means a school corporation that has a current ADM of less than**
11 **two thousand four hundred (2,400).**

12 **Sec. 4. An eligible school corporation is entitled to a small school**
13 **grant as provided in this chapter.**

14 **Sec. 5. If the eligible school corporation's ADM is not more than**
15 **one thousand (1,000) students, the amount of the small school grant**
16 **to which the eligible school corporation is entitled in a state fiscal**
17 **year is the amount determined by multiplying the eligible school**
18 **corporation's ADM by two hundred dollars (\$200).**

19 **Sec. 6. If the eligible school corporation's ADM is at least one**
20 **thousand one (1,001) but not more than two thousand four**
21 **hundred (2,400) students, the amount of the small school grant to**
22 **which the eligible school corporation is entitled in a state fiscal**
23 **year is the amount determined by multiplying the eligible school**
24 **corporation's ADM by one hundred dollars (\$100).**

25 **Sec. 7. (a) There is appropriated to the department from the**
26 **state general fund an amount sufficient to distribute grants to**
27 **eligible school corporations under this chapter for the period**
28 **beginning July 1, 2017, and ending June 30, 2019.**

29 **(b) This section expires July 1, 2019.**
