DIGEST OF INTRODUCED BILL

Citations Affected: IC 6-3-3-14.5.

Synopsis: Tax credit for classroom supplies. Increases the income tax credit for an individual employed as a teacher for amounts expended on classroom supplies from \$100 to \$500 per taxable year.

Effective: January 1, 2019 (retroactive).

HOUSE BILL No. 1144

A BILL FOR AN ACT to amend the Indiana Code concerning taxation.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 6-3-3-14.5, AS ADDED BY P.L.213-2015, SECTION 82, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JANUARY 1, 2019 (RETROACTIVE)]: Sec. 14.5. (a) As used in this section, "classroom supplies" means any items that qualify for the educator expense deduction under Section 62(a)(2)(D) of the Internal Revenue Code. (as effective December 31, 2013).

(b) Each taxable year, an individual employed as a teacher (as defined in IC 20-18-2-22(a)) is entitled to a credit against the individual's adjusted gross income tax liability for amounts expended during the taxable year for classroom supplies. The amount of the credit is the lesser of:

(1) one five hundred dollars (\$100); (\$500); or

(2) the total amount expended for classroom supplies during a taxable year.

(c) The credit provided by this section may not exceed the amount
of the individual's adjusted gross income tax liability for the taxable
year, reduced by the sum of all credits for the taxable year that are
