# HOUSE BILL No. 1150

DIGEST OF INTRODUCED BILL

Citations Affected: IC 31-34.

**Synopsis:** Juvenile victims of human trafficking. Provides that if a petition alleges that a child is a child in need of services as a victim of human or sexual trafficking, the juvenile court shall make a determination on the petition and: (1) the child shall not be required to admit or deny the allegation; and (2) the petitioner must prove the allegation by a preponderance of the evidence. Requires that before or at the initial hearing, the court shall appoint an attorney for a child alleged to be a child in need of services as a victim of human or sexual trafficking.

Effective: July 1, 2024.

A BILL FOR AN ACT to amend the Indiana Code concerning family law and juvenile law.

### Be it enacted by the General Assembly of the State of Indiana:

8	(A) the child is not receiving; and
9	(B) is unlikely to be provided or accepted without the coercive
10	intervention of the court.
11	(b) A child is considered a victim of human or sexual trafficking
12	regardless of whether the child consented to the conduct described in
13	subsection (a)(1).
14	(c) Before or at the initial hearing described in IC 31-34-10-2,
15	the court shall appoint an attorney for the child under this section.

under IC 31-34-1-3.5, the juvenile court shall make a
determination on the petition and the child shall not be required to

admit or deny the allegation. The petitioner must prove the allegation by a preponderance of the evidence.
