

HOUSE BILL No. 1153

DIGEST OF INTRODUCED BILL

Citations Affected: IC 25-42.

Synopsis: High pressure boiler operators. Establishes certification requirements for high pressure boiler operators. Requires that a high pressure boiler operator must hold a license issued by the National Institute for the Uniform Licensing of Power Engineers.

Effective: July 1, 2015.

HOUSE BILL No. 1153

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 25-42 IS ADDED TO THE INDIANA CODE AS
2 A **NEW ARTICLE TO READ AS FOLLOWS** [EFFECTIVE JULY 1,
3 2015]:

4 **ARTICLE 42. HIGH PRESSURE BOILER OPERATORS**

5 **Chapter 1. Definitions**

6 **Sec. 1. As used in this article, "board" refers to the boiler and**
7 **pressure vessel rules board established by IC 22-12-4-1.**

8 **Sec. 2. As used in this article, "boiler horsepower" means the**
9 **power required to evaporate thirty-four and five-tenths (34.5)**
10 **pounds of water at two hundred twelve degrees Fahrenheit (212°F)**
11 **in one (1) hour. One (1) boiler horsepower unit equals a boiler**
12 **thermal output of thirty-three thousand four hundred seventy-five**
13 **British Thermal Units per hour (33,475 BTU/h).**

14 **Sec. 3. As used in this article, "high pressure boiler" means a**
15 **boiler with:**



- 1 (1) a maximum allowable working pressure of at least fifteen
2 (15) pounds per square inch (psi); and
3 (2) more than six (6) boiler horsepower.
- 4 **Sec. 4.** As used in this article, "licensing agency" means the
5 Indiana professional licensing agency established by IC 25-1-5-3.
- 6 **Sec. 5.** As used in this article, "NIULPE" refers to the National
7 Institute for the Uniform Licensing of Power Engineers.
- 8 **Chapter 2. Certification of High Pressure Boiler Operators**
- 9 **Sec. 1.** An individual who operates a high pressure boiler must:
10 (1) be certified as a high pressure boiler operator by the
11 board; and
12 (2) either:
13 (A) hold and maintain a high pressure boiler operator
14 license issued by NIULPE; or
15 (B) work under the direct supervision of a high pressure
16 boiler operator licensed by NIULPE.
- 17 **Sec. 2.** An individual who knowingly, recklessly, or intentionally
18 violates section 1 of this chapter commits a Class C infraction.
- 19 **Sec. 3.** (a) An individual who applies for a high pressure boiler
20 operator certificate must demonstrate that the individual holds a
21 valid high pressure boiler operator license issued by NIULPE.
22 (b) An application for a certificate issued under this section
23 must be:
24 (1) made to the board in the form and manner provided by
25 the board; and
26 (2) accompanied by an application fee in the amount set by
27 the board.
- 28 **Sec. 4.** A certificate issued by the board expires on the earlier of
29 the following dates:
30 (1) Two (2) years from the date of issuance.
31 (2) The expiration date of the NIULPE license issued to the
32 certificate holder.
- 33 **Sec. 5.** An individual who applies to renew a certificate issued
34 under this chapter must:
35 (1) apply for renewal in the manner required by the board;
36 (2) pay a renewal fee established by the board; and
37 (3) demonstrate that the individual holds a valid high pressure
38 boiler operator license issued by NIULPE.
- 39 **Sec. 6.** (a) IC 4-21.5 governs the board's procedures for
40 conducting hearings and issuing subpoenas for witnesses and other
41 evidence.
42 (b) An applicant who is aggrieved by an order or determination



1 of the board under this chapter is entitled to a judicial review
2 under IC 4-21.5.
3 **Sec. 7. The licensing agency shall provide staff and support to**
4 **the board to perform the board's duties under this chapter.**
5 **Sec. 8. The licensing agency shall receive and account for all**
6 **money collected under this chapter and shall deposit the money**
7 **with the treasurer of state, who shall deposit the money in the state**
8 **general fund.**
9 **Sec. 9. The board may adopt rules under IC 4-22-2 needed to**
10 **properly perform its duties under this chapter.**
