DIGEST OF HB 1166 (Updated February 19, 2020 2:37 pm - DI 135)

**Citations Affected:** IC 4-23.

**Synopsis:** State commission and board meetings. Provides that in order for the commission on Hispanic/Latino affairs to take action at a meeting, at least: (1) 11 members must be present; and (2) a majority of the members present at the meeting (instead a majority of members appointed to the commission) must vote in favor of the action.

**Effective:** July 1, 2020.

A BILL FOR AN ACT to amend the Indiana Code concerning state offices and administration.

*Be it enacted by the General Assembly of the State of Indiana:*

1           SECTION 1. IC 4-23-28-8 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 2020]: Sec. 8. ~~The affirmative votes~~  
3 ~~of a majority of the members appointed to the commission are required~~  
4 For the commission to take action on any measure, including final  
5 reports, **at least:**  
6           **(1) eleven (11) members must be present at the meeting; and**  
7           **(2) a majority of the members present at the meeting must**  
8           **vote in favor of the action.**
