DIGEST OF INTRODUCED BILL

Citations Affected: IC 35-48-1-19.

Synopsis: Industrial hemp. Provides that the exemption of industrial hemp from the definition of "marijuana" includes the fiber, seeds, resin, and oil or any other compound extracted, derived, manufactured, or prepared from any part of an industrial hemp plant.

Effective: July 1, 2015.

HOUSE BILL No. 1181



A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 35-48-1-19, AS AMENDED BY P.L.165-2014,
- 2 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 3 JULY 1, 2015]: Sec. 19. (a) "Marijuana" means any part of the plant
- 4 genus Cannabis whether growing or not; the seeds thereof; the resin
- 5 extracted from any part of the plant, including hashish and hash oil; any
- 6 compound, manufacture, salt, derivative, mixture, or preparation of the
- 7 plant, its seeds or resin.
- 8 (b) The term does not include:
- 9 (1) the mature stalks of the plant;
- 10 (2) fiber produced from the stalks;
- 11 (3) oil or cake made from the seeds of the plant;
- 12 (4) any other compound, manufacture, salt, derivative, mixture,
- 13 or preparation of the mature stalks (except the resin extracted
- 14 therefrom);
- 15 (5) the sterilized seed of the plant which is incapable of



1 germination; or
2 (6) industrial hemp (as defined by IC 15-15-13-6), **including the**
3 **fiber, seeds, resin, and oil or any other compound extracted,**
4 **derived, manufactured, or prepared from any part of an**
5 **industrial hemp plant.**
