DIGEST OF HB 1187 (Updated February 16, 2016 11:35 am - DI 84)

**Citations Affected:** IC 35-43.

**Synopsis:** Stolen valor. Makes it committing stolen valor, a Class A misdemeanor, for a person to knowingly or intentionally, with the intent to obtain money, property, or another benefit: (1) fraudulently represent himself or herself to be an active member or veteran of the armed forces of the United States; (2) use falsified military identification; or (3) fraudulently claim to be the recipient of certain military honors.

**Effective:** July 1, 2016.

## ENGROSSED HOUSE BILL No. 1187

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 35-43-5-22 IS ADDED TO THE INDIANA CODE  
2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2016]: **Sec. 22. A person who, with the intent to obtain money,  
4 property, or another benefit, knowingly or intentionally:**  
5 (1) fraudulently represents himself or herself to be an active  
6 member or veteran of:  
7 (A) the United States Air Force;  
8 (B) the United States Army;  
9 (C) the United States Coast Guard;  
10 (D) the United States Marines;  
11 (E) the United States National Guard;  
12 (F) the United States Navy; or  
13 (G) a reserve component of the armed forces of the United  
14 States;  
15 (2) uses a falsified military identification; or  
16 (3) fraudulently represents himself or herself to be a recipient
