

HOUSE BILL No. 1187

DIGEST OF HB 1187 (Updated January 21, 2014 6:13 pm - DI 84)

Citations Affected: IC 36-9.

Synopsis: Extraterritorial municipal sewage works. Defines "overlapping area". Provides that an ordinance adopted before July 1, 2014, that prohibits a municipality from providing sewage treatment service to certain customers is void. Provides that an ordinance adopted after June 30, 2014, that prohibits a municipality from providing sewage treatment service in an overlapping area is void.

Effective: July 1, 2014.

HOUSE BILL No. 1187

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 36-9-2-16 IS AMENDED TO READ AS
FOLLOWS [EFFECTIVE JULY 1, 2014]: Sec. 16. Except as
provided in IC 36-9-23-36.5, a unit may regulate the furnishing of the
service of collecting, processing, and disposing of waste substances
and domestic or sanitary sewage. This includes the power to fix the
price to be charged for that service.
SECTION 2. IC 36-9-2-18 IS AMENDED TO READ AS
FOLLOWICE FEED CERVE HILVIA 2014 I.C. 10 A 11.

FOLLOWS [EFFECTIVE JULY 1, 2014]: Sec. 18. A municipality may exercise powers granted by sections 2, 3, 14, 16, and 17 of this chapter in areas within four (4) miles outside its corporate boundaries. However, the exercise of the powers granted by sections 16 and 17 of this chapter is subject to IC 36-9-23-36.5.

SECTION 3. IC 36-9-2-19 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2014]: Sec. 19. **Subject to IC 36-9-23-36.5**, **if applicable**, a municipality may exercise powers granted by sections 9, 10, 11, 12, and 13 of this chapter in areas within
