DIGEST OF INTRODUCED BILL

Citations Affected: IC 3-11-10-26.3.

Synopsis: Satellite offices. Allows a county election board to adopt a resolution by the majority vote of the board's entire membership in order to establish satellite locations for early voting. (Currently, a resolution to establish satellite voting locations must be adopted unanimously by the board.)

Effective: July 1, 2017.

A BILL FOR AN ACT to amend the Indiana Code concerning elections.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 3-11-10-26.3, AS AMENDED BY P.L.169-2015,
2	SECTION 123, IS AMENDED TO READ AS FOLLOWS
3	[EFFECTIVE JULY 1, 2017]: Sec. 26.3. (a) A county election board
4	may adopt a resolution to authorize the circuit court clerk to establish
5	satellite offices in the county where voters may cast absentee ballots
6	before an absentee voter board.
7	(b) To be adopted under this section, a resolution must be adopted
8	by the unanimous majority vote of the board's entire membership.
9	(c) A resolution adopted under this section must do the following:
10	(1) State the locations of the satellite offices.
11	(2) State the hours at which absentee voting may occur at the
12	satellite offices.
13	(d) The resolution may contain other provisions the board considers
14	useful.
15	(e) If a resolution is adopted under this section for a primary
16	election, the locations of the satellite offices and the hours at which
17	absentee voting may occur at the satellite offices established for the

1	primary election must be used for the subsequent general or municipal
2	election.
3	(f) If a resolution is adopted under this section, the procedure for
4	casting an absentee ballot at a satellite office must, except as provided
5	in this section, be substantially the same as the procedure for casting an
6	absentee ballot in the office of the circuit court clerk under section 26
7	of this chapter.
8	(g) A voter casting an absentee ballot under this section is entitled
9	to cast the voter's ballot in accordance with IC 3-11-9.
10	(h) A satellite office established by a circuit court clerk under this
11	section must comply with the polling place accessibility requirements
12	of IC 3-11-8.
13	(i) A resolution adopted under this section expires January 1 of the
14	year immediately after the year in which the resolution is adopted.
