## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 2-5-29.

**Synopsis:** Youth Advisory Council. Increases the membership of the youth advisory council (council) from 22 members to 23 members. Provides that the Indiana association of student councils designates the additional member of the council. Provides that the council may adopt bylaws to govern its organization and proceedings.

**Effective:** July 1, 2015.

## HOUSE BILL No. 1198

A BILL FOR AN ACT to amend the Indiana Code concerning the general assembly.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 2-5-29-3, AS AMENDED BY P.L.113-2010,  
2 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2015]: Sec. 3. (a) The council consists of the following  
4 ~~twenty-two (22)~~ **twenty-three (23)** members, who must be at least  
5 sixteen (16) years of age and not more than twenty (20) years of age at  
6 the time of appointment:  
7 (1) Five (5) members appointed by the president pro tempore of  
8 the senate.  
9 (2) Five (5) members appointed by the minority leader of the  
10 senate.  
11 (3) Five (5) members appointed by the speaker of the house of  
12 representatives.  
13 (4) Five (5) members appointed by the minority leader of the  
14 house of representatives.  
15 (5) Two (2) members appointed by the governor.



1           **(6) One (1) member designated by the Indiana association of**  
2           **student councils.**  
3           (b) The members of the council shall be selected so as to give  
4 representation to the various geographical areas of Indiana.  
5           (c) The members of the council shall annually elect a chairperson  
6 of the council from among the members.  
7           (d) Members of the council shall serve for a two (2) year term and  
8 may be reappointed.  
9           (e) The appointing authority may remove an appointed member of  
10 the council for cause. Cause includes the failure to attend at least two  
11 (2) meetings within a one (1) year period.  
12           SECTION 2. IC 2-5-29-5.5 IS ADDED TO THE INDIANA CODE  
13 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
14 1, 2015]: **Sec. 5.5. The council may adopt bylaws to govern its**  
15 **organization and proceedings.**
