DIGEST OF INTRODUCED BILL

Citations Affected: IC 6-1.1-18.5-27.

Synopsis: Fire and emergency medical service levies. Provides a procedure for Vernon Township of Hancock County to obtain an increase of Vernon Township's maximum permissible ad valorem property tax levy for fire and emergency medical services.

Effective: Upon passage.

HOUSE BILL No. 1202

A BILL FOR AN ACT to amend the Indiana Code concerning taxation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 6-1.1-18.5-27 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE UPON PASSAGE]: **Sec. 27. (a) This section applies**
4 **only to Vernon Township in Hancock County.**

5 **(b) The executive of the township may, upon approval by the**
6 **township fiscal body, submit a petition to the department of local**
7 **government finance for an increase in the township's maximum**
8 **permissible ad valorem property tax levy for fire and emergency**
9 **medical services for property taxes first due and payable in 2021.**

10 **(c) If the executive of the township submits a petition in**
11 **accordance with subsection (a) before August 1, 2020, the**
12 **department of local government finance shall increase the**
13 **township's maximum permissible ad valorem property tax levy for**
14 **fire and emergency medical services for property taxes first due**
15 **and payable in 2021 to one million eight hundred forty-eight**
16 **thousand thirty-seven dollars (\$1,848,037).**

17 **(d) The township's maximum permissible ad valorem property**



1 tax levy for fire and emergency medical services for property taxes
2 first due and payable in 2021, as adjusted under this section, shall
3 be used in the determination of the township's maximum
4 permissible ad valorem property tax levy for fire and emergency
5 medical services for property taxes first due and payable after
6 2021.

7 (e) This section expires June 30, 2025.

8 SECTION 2. An emergency is declared for this act.
