

HOUSE BILL No. 1215

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-43.

Synopsis: Small school grants. Reestablishes a small school grant for school corporations having a current ADM (average daily membership) of less than 2,400. Appropriates from the state general fund an amount sufficient to make the grants for the 2019-2021 biennium.

Effective: July 1, 2019.

HOUSE BILL No. 1215

A BILL FOR AN ACT to amend the Indiana Code concerning education and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-43-2-3, AS AMENDED BY P.L.135-2018,
2 SECTION 3, AND AS AMENDED BY P.L.192-2018, SECTION 47,
3 AND AS AMENDED BY THE TECHNICAL CORRECTIONS BILL
4 OF THE 2019 GENERAL ASSEMBLY, IS CORRECTED AND
5 AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2019]:
6 Sec. 3. ~~If the total amount to be distributed:~~ In determining the total
7 amount to be distributed for purposes of section 2 of this chapter,
8 distributions:
9 (1) as basic tuition support;
10 (2) for honors ~~diploma~~ designation awards;
11 (3) for complexity grants;
12 (4) for special education grants;
13 (5) for career and technical education grants;
14 (6) for choice scholarships; ~~and~~
15 (7) for Mitch Daniels early graduation scholarships; **and**
16 **(8) for small school grants;**
17 *are to be considered* for a particular state fiscal year. ~~exceeds the~~



1 *amounts appropriated by the general assembly for those purposes for*
 2 *the state fiscal year; the total amount to be distributed for those*
 3 *purposes to each recipient during the remaining months of the state*
 4 *fiscal year shall be proportionately reduced so that the total reductions*

6 SECTION 2. IC 20-43-16 IS ADDED TO THE INDIANA CODE
 7 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
 8 JULY 1, 2019]:

9 **Chapter 16. Small School Grants**

10 **Sec. 1. This chapter does not apply to a charter school.**

11 **Sec. 2. This chapter applies to a state fiscal year beginning after**
 12 **June 30, 2019.**

13 **Sec. 3. As used in this chapter, "eligible school corporation"**
 14 **means a school corporation that has a current ADM of less than**
 15 **two thousand four hundred (2,400).**

16 **Sec. 4. An eligible school corporation is entitled to a small school**
 17 **grant as provided in this chapter.**

18 **Sec. 5. If the eligible school corporation's ADM is not more than**
 19 **one thousand (1,000) students, the amount of the small school grant**
 20 **to which the eligible school corporation is entitled in a state fiscal**
 21 **year is the amount determined by multiplying the eligible school**
 22 **corporation's ADM by two hundred dollars (\$200).**

23 **Sec. 6. If the eligible school corporation's ADM is at least one**
 24 **thousand one (1,001) but not more than two thousand four**
 25 **hundred (2,400) students, the amount of the small school grant to**
 26 **which the eligible school corporation is entitled in a state fiscal**
 27 **year is the amount determined by multiplying the eligible school**
 28 **corporation's ADM by one hundred dollars (\$100).**

29 **Sec. 7. (a) There is appropriated to the department from the**
 30 **state general fund an amount sufficient to distribute grants to**
 31 **eligible school corporations under this chapter for the period**
 32 **beginning July 1, 2019, and ending June 30, 2021.**

33 **(b) This section expires June 30, 2021.**
