DIGEST OF HB 1216 (Updated February 12, 2019 11:57 am - DI 113)

Citations Affected: IC 12-12.7.

Synopsis: First steps program. Provides that, for purposes of determining a family's income under the first steps program, a family is presumed to have an income that is not more than 250% of the federal income poverty level if the family is receiving benefits under Medicaid, the Supplemental Nutrition Assistance Program (SNAP), or the Temporary Assistance for Needy Families (TANF) program.

Effective: July 1, 2019.

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 12-12.7-2-17.3 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2019]: **Sec. 17.3. Subject to any federal**
4 **requirements under 20 U.S.C. 1431 et seq., for purposes of**
5 **determining a family's income under section 17 of this chapter, a**
6 **family is presumed to have an income that is not more than two**
7 **hundred fifty percent (250%) of the federal income poverty level**
8 **if the family is receiving benefits under any of the following:**
9 (1) **The Medicaid program.**
10 (2) **The Supplemental Nutrition Assistance Program (SNAP).**
11 (3) **The Temporary Assistance for Needy Families (TANF)**
12 **program.**
13 (4) **Any other program approved by the division.**
