ENGROSSED HOUSE BILL No. 1218

DIGEST OF HB 1218 (Updated February 13, 2020 11:12 am - DI 101)

Citations Affected: IC 8-1.

Synopsis: Locating underground utility infrastructure. Amends the statute concerning the location of underground utility facilities (state 811 law) to provide that for any new or replacement underground facility that an operator installs or causes to be installed after June 30, 2020, the operator shall ensure that: (1) the materials from which the facility is constructed are capable of being detected from above ground level using standard equipment and technologies used by the utility locating industry; or (2) if the materials from which the facility is constructed are not capable of being detected from above ground level using standard locating techniques, the facility is encased by conductive material or is equipped with an electrically conducting wire or other means of locating the facility while it is underground.

Effective: Upon passage.

ENGROSSED HOUSE BILL No. 1218

A BILL FOR AN ACT to amend the Indiana Code concerning utilities.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 8-1-26-18.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: **Sec. 18.5. (a) This section applies to any new or**
4 **replacement underground facility that an operator installs or**
5 **causes to be installed after June 30, 2020, in any public**
6 **right-of-way or on any private property.**
7 **(b) Subject to any other applicable federal or state laws or**
8 **regulations, for any new or replacement underground facility that**
9 **an operator installs or causes to be installed, the operator shall**
10 **ensure that:**
11 **(1) the materials from which the facility is constructed are**
12 **capable of being detected from above ground level using**
13 **standard equipment and technologies used by the utility**
14 **locating industry, such as electromagnetic locating equipment**
15 **and electromagnetic induction surveys; or**
16 **(2) if the materials from which the facility is constructed are**
17 **not capable of being detected from above ground level using**

1 **standard locating techniques, as described in subdivision (1),**
2 **the facility is:**
3 **(A) encased by conductive material; or**
4 **(B) equipped with an electrically conducting wire or other**
5 **means of locating the facility while it is underground.**
6 **(c) The commission may adopt rules under IC 4-22-2 to**
7 **implement this section, including emergency rules in the manner**
8 **provided under IC 4-22-2-37.1. Notwithstanding IC 4-22-2-37.1(g),**
9 **an emergency rule adopted by the commission under this**
10 **subsection and in the manner provided under IC 4-22-2-37.1**
11 **expires on the date on which a rule that supersedes the emergency**
12 **rule is adopted by the commission under IC 4-22-2-24 through**
13 **IC 4-22-2-36.**
14 **SECTION 2. An emergency is declared for this act.**

Page 1, line 14, delete "surveys, and ground penetrating" and insert "**surveys; or**".

Page 1, delete line 15.

Page 1, line 16, delete "subject to subsection (c)".

Page 2, delete lines 6 through 12.

Page 2, line 13, delete "(e)" and insert "**(c)**".
