DIGEST OF HB 1230 (Updated February 6, 2017 10:57 am - DI 84)

**Citations Affected:** IC 13-11; IC 13-19.

**Synopsis:** Regulation of coal combustion residuals. Authorizes the environmental rules board to adopt rules consistent with the regulations of the United States Environmental Protection Agency concerning standards for the disposal of coal combustion residuals in landfills and surface impoundments.

**Effective:** Upon passage.

## ENGROSSED HOUSE BILL No. 1230

---

A BILL FOR AN ACT to amend the Indiana Code concerning environmental law.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 13-11-2-30.8 IS ADDED TO THE INDIANA  
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE UPON PASSAGE]: **Sec. 30.8. "Coal combustion**  
4 **residuals", for purposes of IC 13-19-3-3, has the meaning set forth**  
5 **in IC 13-19-3-3(a).**

6 SECTION 2. IC 13-19-3-3 IS AMENDED TO READ AS  
7 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 3. **(a) As used in**  
8 **this section, "coal combustion residuals" means fly ash, bottom**  
9 **ash, boiler slag, and flue gas desulfurization materials generated**  
10 **from burning coal for the purpose of generating electricity by**  
11 **electric utilities and independent power producers.**

12 **(b) Except as provided in subsection (c),** the board may not adopt  
13 rules under section 1 of this chapter to regulate the following:

14 (1) The disposal of waste indigenous to the coal mining process  
15 and coal combustion products (as defined by ASTM E-2201-02a),  
16 including fly ash, bottom ash, boiler slag, fluidized bed  
17 combustion ash, or flue gas desulfurization material produced

1 from the combustion of coal or the cleaning of stack gases on coal  
2 combustion units if the material:

3 (A) is not included in the definition of hazardous waste or is  
4 exempt from regulation as a hazardous waste under 42 U.S.C.  
5 6921; and

6 (B) is disposed of at a facility regulated under IC 14-34.

7 (2) The use of coal combustion products (as defined by ASTM  
8 E-2201-02a), including fly ash, bottom ash, boiler slag, fluidized  
9 bed combustion ash, or flue gas desulfurization material produced  
10 from the combustion of coal or the cleaning of stack gases on coal  
11 combustion units, if the use includes one (1) of the following  
12 uses:

13 (A) The extraction or recovery of materials and compounds  
14 contained within coal combustion products.

15 (B) Bottom ash as an antiskid material.

16 (C) Raw material for manufacturing another product.

17 (D) Mine subsidence, mine fire control, and mine sealing.

18 (E) Structural fill when combined with cement, sand, or water  
19 to produce a controlled strength fill material.

20 (F) A base in road construction.

21 (G) Cover for coal processing waste disposal locations to  
22 inhibit infiltration at surface and underground mines subject  
23 to IC 14-34, so long as a demonstration is made in concurrence  
24 with the department of natural resources that the materials and  
25 methods to be employed are appropriate for the intended use.

26 (H) Providing buffering or enhancing structural integrity for  
27 refuse piles at surface and underground mines subject to  
28 IC 14-34, so long as a demonstration is made in concurrence  
29 with the department of natural resources that the materials and  
30 methods to be employed are appropriate for the intended use.

31 (I) Agricultural applications, when applied using appropriate  
32 agronomic amounts to improve crop or vegetative production.

33 **(c) The board may adopt rules under section 1(1) of this chapter**  
34 **that are consistent with the regulations of the United States**  
35 **Environmental Protection Agency concerning standards for the**  
36 **disposal of coal combustion residuals in landfills and surface**  
37 **impoundments, as set forth in 40 CFR 257.50 et seq.**

38 **SECTION 3. An emergency is declared for this act.**
